RE: Draft 2011-2014 Transportation Improvement Program for the Twin Cities Metropolitan Area: Report on public comments and staff recommendations.

The Transportation Advisory Board held a 45-day public comment period on the draft 2011-2014 Transportation Improvement Program, beginning on May 19 and ending on July 6, 2010. All comments received outside of the public hearing held on June 16, 2010 are attached to this memo. Below is a summary of the comments received during the public comment period with staff response and recommendations.

COMMENTS RECEIVED DURING THE PUBLIC COMMENT PERIOD

Lisa J. Freese, Transportation Program Manager, Scott County. Staff received a letter dated June 22, 2010 with the following two comments:

Scott County: 1) HSIP project SP# 70-617-23 (CSAH 17 and CSAH 42 interchange) be moved from the current 2014 to 2013. 2) Transportation Enhancement project 70-701-08 (CSAH 101 Trail) be moved from the current year 2014 to 2013.

Staff response and recommendation: Both projects were awarded federal funds in the 2009 regional solicitation and programmed in 2014. Scott County requested that the Enhancement project be programmed in 2013 but the HSIP solicitation process does not ask project sponsors for a program year preference. MN/DOT Metro Program Management programs local projects from the regional solicitation in consultation with Council staff. The main goal in programming local projects is to balance the federal funds available with the federal funds requested in 2013 and 2014 to maintain fiscal constraint. In the 2009 solicitation, many more projects asked for a 2013 program year than could be accommodated, so several projects had to be programmed in 2014.

To move these two projects to the 2013 program year, another project(s) must be moved from 2013 to 2014. Staff contacted MN/DOT Metro State Aid for their assessment of local projects but they could not identify any local projects in 2013 that should be moved to 2014. Scott County was awarded federal funding for two other projects in the 2009 regional solicitation and both are programmed in 2013. Staff recommends that the HSIP and Enhancement projects not be moved to the 2013 program year at this time. During the Local Program Review in January and March 2011, there may be an opportunity to move both projects up to 2013 as other local projects fall behind schedule.

2011 2014 TIP public comment responses.

Kim Lindquist, Community Development Director, City of Rosemount. Staff received a letter dated June 25, 2010 with the following comment:

Rosemount: The cost estimates for a CMAQ project awarded to the city in the 2009 regional solicitation that appear in the draft 2011-2014 TIP are not consistent with the cost estimates in the application. The city provided a table showing the federal, match and total costs according to their estimates.

Staff response and recommendation: Rosemount was awarded CMAQ funds in the 2009 regional solicitation to construct a passenger facility, purchase four buses and provide start-up operating funds for a new transit service route. Each project component was programmed separately in the draft 2011-2014 TIP, but apparently the figures for each element are not correct. Staff recommends that the draft TIP be corrected to reflect the cost figures for each element that was provided by the city.

Brian Lamb, General Manager, Metro Transit. Staff received a letter dated June 28, 2010 with the following comment:

Metro Transit: Projects SP# 91-596-01 (300 car P&R in Blaine) and SP# TRS-TCMT-10B (Purchase 6 articulated buses) were awarded CMAQ funding in the 2005 regional solicitation and programmed in 2010 with a sunset date of March 31, 2011. Both projects should be listed in the 2011 program year.

Staff response and recommendation: Due to a miscommunication between Metro Transit and MN/DOT Metro Program Management, these two projects were not included in the draft TIP. Regional policy does include a sunset date provision for CMAQ projects, making the federal funds available until March 31 of the year after the project's original program year. Staff recommends that these two projects be included in the program year 2011 of the draft 2011-2014 TIP.

Jim Gates, Deputy Director of Public Works, City of Bloomington. Staff received a letter dated April 30, 2010 with the following comment:

Bloomington: Change the project description and cost estimate of SP# 107-090-05 (Replace Long Meadow Bridge 3145). Bloomington has completed a feasibility study and wishes to pursue two alternatives, replace or renovate, at a higher cost figure, \$10.0 M compared to the programmed amount of \$4.5 M.

Staff response and recommendation: Staff consulted with the FHWA field office who advised that the requested change should be treated as a scope change and TIP amendment request through the normal TAC/TAB process. Staff recommends that the project description and cost estimate not be revised at this time; however, Bloomington may pursue a scope change and TIP amendment at any time.

<u>Mike Klassen, Senior Engineer, City of St. Paul.</u> Staff received a letter dated July 6, 2010 with the following comment:

St. Paul: Change the project description and cost estimate of the Central Corridor Streetscape Enhancement project (SP# 164-0820-113) to remove project elements that were let with the Central Corridor Civil East bid package and move the remaining Enhancement work to program year 2011.

Staff response and recommendation: St. Paul was awarded \$1.0 M in Transportation Enhancement funding in the 2009 regional solicitation to provide streetscape amenities in the Central Corridor LRT project area. These amenities were not part of the CCLRT project scope or New Starts application. The St. Paul Enhancement project is matched with almost \$18.0 M in non-federal funds. To avoid contractor coordination problems, St. Paul added most of the streetscape amenities to the Civil East bid package, leaving tree planting as the last remaining element of the Enhancement project to be completed under a separate contract.

All elements of the Central Corridor Streetscape Enhancement project will be constructed as described in the application. Adding most of the project elements to the Civil East bid package was necessary to ensure deliverability of the streetscape amenities. Staff recommends revising the project scope and cost elements as requested and to program the project in 2011.

<u>Scott McBride, Metro District Engineer, Minnesota Dept. of Transportation.</u> Staff received a letter dated July 6, 2010 requested that a number of changes be made to state and local projects listed in the Public Hearing copy of the draft 2011-2014 TIP. Attached to the letter were several tables listing projects to be deferred, projects to be deleted, projects to be advanced and a table of new projects to be added.

Staff response and recommendation: The changes described in the tables sent with Mr. McBride's letter reflect MN/DOT's normal end of fiscal year balancing changes, updated project cost estimates, new project funding commitments and projects shifting among program years within the TIP timeframe. Staff recommends that the changes provided in the attached tables be incorporated into the 2011-2014 TIP.

- 1. <u>HSIP Project 70-617-23 CSAH 17 and CSAH 42 Interchange</u>. We request that this project be moved from the current 2014 year to 2013. This project has the third highest B/C out of 20 reactive safety projects. The County plans to construct this project in 2011. The County requested to advance construct this project in 2011 through Mn/DOT Metro District State Aid and understand that will also be acknowledged in the final TIP document.
- Enhancement Project 70-701-08 CSAH 101 Trail. We request this project to be moved from the current 2014 year to 2013. This project ranked #5 out of 21 funded Enhancement projects in the last solicitation. Bloomington would like to request a minor verbiage revision in the description language for Project Number 107-090-05 as the 2011-2014 TIP moves forward. This change, below, would allow maximum flexibility to meet the intent of the original project application for the use of funding as the project moves through the environmental process (NEPA).

Long Meadow Lake Bloomington – Replace or renovate BR 3145 on Old Cedar Ave with a ped bike boardwalk connection.

The City of Bloomington has been pursuing replacement or renovation of formerly designated Bridge #3145 (now off-system) for decades, which now has the possibility of being funded.

Bloomington has now completed the Feasibility Study portion of the NEPA process. The various alternatives vary from the original replacement estimate of \$4.5 million to a \$10 million rehabilitation option. No additional "enhancement" dollars are requested. Additional funding opportunities have surfaced since the original project submittal that may be implemented as the project proceeds.

The project goal of restoring a ped/bike connection over Long Meadow Lake remains unchanged. Replacement and renovation of Old Cedar Bridge (formerly #3145) are the two remaining alternatives for the connection to local and regional trails in the natural and cultural elements of the Minnesota River valley. These verbiage revisions will allow maximum project flexibility as Bloomington continues to move through the NEPA process.

Kevin,

Following the notification that the City would be awarded funding for the Central Corridor Streetscape Enhancement Project, City staff scheduled a meeting with the Central Corridor LRT Project Team to review all of the proposed streetscape elements and determine the most efficient (best) way to provided/deliver the individual elements. It was determined that to maximize public benefit and minimize construction coordination problems, all of the elements except the boulevard trees should be let as part of the Central Corridor LRT Civil East bid package. The purchase, installation and warranty of the boulevard trees could be efficiently bid separately as the trees can be installed anytime after the Civil East construction elements are completed and avoid contractor coordination problems.

Therefore, the City needs to ask that the scope of the Central Corridor Streetscape Enhancement Project be changed to include all trees located within the City Saint Paul along the Central Corridor LRT project. The estimated cost for this revised work (furnish, install and warranty about 1,500 trees) is \$1,300,000.00. \$1,000,000 Federal Enhancement funds and \$300,000 local hard match. To best coordinate with the Metropolitan Council's Central Corridor Civil East Project we are also asking that the project be moved to program year 2011.

Just to clarify, none of the these streetscape elements were part of the Central Corridor LRT project scope, all elements listed in the original enhancement proposal will be constructed and the City will provide the full needed local match for these elements. The difference is that to maximize benefit and minimize construction coordination issues, the elements will be installed under two bid packages. The trees as a separate enhancement project and the balance as part of the Central Corridor LRT Civil East bid package.

The Minnesota Department of Transportation (MnDOT) has worked closely with the staff of the Metropolitan Council and the Transportation Advisory Board (TAB) and the Technical Advisory Committee (TAC) in development of the draft 2011-2014 Transportation Improvement Program (TIP). Information was supplied in April 2010 for the project and summary tables. Several minor changes have occurred since that time, including end-of-year changes affecting a number of individual projects.

The attached four tables identify the individual proposed changes to the draft 2011-2014 TIP. These changes are, for the most part, end of fiscal year balancing changes, and projects shifting among years of the TIP along with any additions or deletions. In addition to changes in these tables, some changes have been made to "Advance Construction" and "Advance Construction" paybacks due to projects moving between years of the TIP, and actual project letting costs have been updated.

With the proposed changes, we believe that the TTP remains fiscally balanced in the first two years, and generally balanced in the remaining years. These proposed changes do not affect the air quality conformity analysis of the TIP, as we have discussed with staff of the Minnesota Pollution Control Agency and the Metropolitan Council.
