Proposed Action

That the Metropolitan Council concur with the attached Transportation Advisory Board (TAB) action to amend the 2010-2013 Transportation Improvement Program (TIP) to include 20 funding awards through the Section 5310, Elderly and Persons with Disabilities Program.

Background

The timing of project selection for small bus purchases is not compatible with the TIP/STIP development, therefore, a separate action is needed to allow purchase in SFY 2010.

Rationale
