Policy Implementation

- Review Trail planning coordination needs.
- Review master plan approval procedures for new trails
- Review anticipated acquisition needs for trails and park in 2007-08.
- Prepare the 2008-13 Parks CIP as part of Metropolitan Council's 2008-13 Unified CIP
 - June 1, 2007 Decision on amount to request for 2008 State bonds and 2009 LCCMR funds as part of 2008-09 Parks CIP projected revenue streams. This also determines projected amount of Metropolitan Council bond match. Same amounts are assumed for 2010-13
 - June 15, 2007 submittal of preliminary 2008 State bond request for the 2008-09 Parks CIP to MN Dept. of Finance
 - Sept. 1, 2007 complete draft for hearing version of 2008-13 ParksCIP and forward to Metropolitan Council
 - Sept. 30, 2007 submit final 2008 State bond request based on 2008-09 Parks CIP draft
 - November 2007 Metropolitan Council holds hearing on 2008-13 Unified CIP including 2008-13 Parks CIP
 - December 2007 Metropolitan Council adopts 2008-13 Unified CIP including 2008-13 Parks CIP
- Review and assist Regional Park Foundation initiative
- Review decennial survey design
- Coordinate and participate in Regional Policy Conference (40th anniversary of Council event)
