BACKGROUND

 November 16, 2006 Metropolitan Council received the Gardas Grove 2nd Addition comprehensive plan amendment (CPA)

- January 18, 2007 Council finds CPA complete for review
- February 5, 2007 CDC sets public hearing for proposed plan modification
- March 5, 2007 CDC holds public hearing
- April 16, 2007 CDC accepts City request to extend CPA review to July 15, 2007
- June 18, 2007 CDC scheduled action
- June 27, 2007 scheduled Metropolitan Council action
- June 12, 2007 Council received City request and 90 day extension to the CPA review (review period ends October 13, 2007)

PROPOSED CPA

The CPA proposes to reguide 20 acres from Agriculture, one unit per ten acres, to Single-Family Residential which permits development at a density of one dwelling unit per 2.5 acres.

REVIEW UPDATE

On June 12, 2007, the City of Oak Grove requested a 90 day extension for the CPA. The City recognizes that on August 22, 2007, the Metropolitan Council is anticipated to adopt an amendment to the 2030 Water Resources Management Policy Plan that identifies potential future sewer service areas within the City of Oak Grove, associated with the proposed East Bethel regional wastewater treatment facility.

The Gardas Grove 2nd Addition CPA is located outside this potential future sewer service area. The review extension allows the Council to delay action on the CPA until after the Council acts on the proposed amendment.

PROPOSED ACTION


Staff recommends that the Community Development Committee:

- Accept the CPA review schedule extension to October 13, 2007.
- Delay Committee action on the CPA until the Council acts on the proposed 2030 Water Resources Management Policy Plan.
