Subject: Guidelines for Extensions to Local Governments to Complete Local

Comprehensive Plan Updates; LCA Grant Agreements with

Communities that have not Submitted Plan Updates

Proposed Action

That the Metropolitan Council adopts the following guidelines applicable to local units of government that are granted requests to extend the deadline for comprehensive plan update:

- 1. Staff may administratively grant an extension to April 30, 2009 for submittal of the 2008 comprehensive plan update if (a) a community submits the extension request and required materials by November 1, 2008; and (b) the request includes a reasonably detailed timetable and plan for completing the review and amendment of the comprehensive plan update, the community's fiscal devices, and the community's official controls. The mandatory 6-month adjacent jurisdiction review process must be completed by that submittal date.
- 2. Communities identifying conflicts in forecasts or obstacles to plan completion may be asked to meet with Metropolitan Council staff and/or Metropolitan Council member(s) for their district to resolve outstanding issues.
- 3. If a comprehensive plan update cannot be submitted by April 30, 2009, with the mandatory 6-month adjacent community review complete, an extension of the submittal date will require action by the Metropolitan Council's governing body. A request for an extension of submittal beyond April 30, 2009 will require submittal of the extension request documents and must be made by November 1, 2008. The local government representative must also make a presentation of the request directly to the Council's Community Development Committee at one of the Committee's regularly scheduled meetings.
- 4. After December 31, 2008, a community should not submit comprehensive plan amendments until the Metropolitan Council has acted on the community's 2008 comprehensive plan update.
- 5. An extension of the comprehensive plan completion deadline does not change any due dates for surface water plans or Critical Area/MNRRA plan funding agreements.
- 6. For LCA grants awarded after December 31, 2008, the Metropolitan Council will not execute an LCA grant agreement with any grantee community that has not submitted to the Council a comprehensive plan update that is complete for review.

Background

Minnesota Statutes section 473.864 requires all local governments in the seven-county metropolitan area to review and update their local comprehensive plans and submit those updates to the Metropolitan Council for review and comment by December 31, 2008. These statutes also require local governmental units to review and, as necessary, amend their fiscal devices and official controls. Section 473.864 authorizes the Council to grant extensions to local government units if they need additional time to complete their comprehensive plan reviews and revisions. According to the statute, any extensions granted by the Council "must include a timetable and plan for completion of the review and amendment." The Metropolitan Land Planning Act requires the Council

to establish guidelines and procedures to which local governmental units must conform when preparing, adopting, and submitting their plans.

Rationale

A number of local units of government have informed the Council that they will be unable to submit their comprehensive plan updates to the Council by the deadline of December 31, 2008, with the mandatory sixmonth adjacent jurisdiction review process complete. The proposed action is based on the premise that it is reasonable to extend the December 31, 2008 deadline to April 30, 2009, provided that communities complete their draft plans and submit them to adjacent jurisdictions by the December 31, 2008 deadline, and provided that they formally inform and formally request an extension by November 1, 2008. Communities that require extensions beyond this period must submit the required request documents by November 1, 2008 and make their request for extension directly to the Council's Community Development Committee at one of its regularly scheduled meetings.

It is reasonable to expect that the Metropolitan Council will not consider comprehensive plan amendments to local plans for communities that have not met the comprehensive plan update submittal requirements by December 31, 2008, as required by the Metropolitan Land Planning Act. It is uncertain whether existing plans that have not been updated as required conform to or are consistent with the Council's 2030 Regional Development Framework and accompanying regional system plans. Communities should not submit any amendments to their existing local plans until that community's comprehensive plan update has been reviewed by the Metropolitan Council. To this end, staff is preparing a proposed action for the Council's review at a future meeting that would set guidelines and procedures, pursuant to Minnesota Statutes section 473.854, describing the conditions under which the Council will not entertain plan amendments, including for those communities who have not updated their local comprehensive plans by the required local plan update submission date.

Section 473.25(a) of the Metropolitan Livable Communities Act requires the Council to establish criteria for uses of the Metropolitan Livable Communities Fund "that are consistent with and promote...policies of the Metropolitan Development Guide adopted by the council." The Act also requires the Council to "establish guidelines governing who may apply for a grant or loan from the fund." To help ensure that LCA-supported projects and related developments are consistent with the Council's 2030 Regional Development Framework and its regional policy plans for water resources, transportation, and regional parks and open space, the Council should consider making the availability of LCA funds contingent on a grantee community's compliance with the "decennial" review requirements of the Metropolitan Land Planning Act.

Staff anticipates that many communities will very soon ask questions regarding the timing of subsequent plan amendments, deadlines for other required plans, potential for other deadlines extensions, the handling of local issues that may be hindering completion of the update, and forecast disagreements. To avoid confusion, staff recommends adopting these guidelines and distributing information about the extension process to local units of government.

Funding

The Council has made planning grants to 49 communities and counties of approximately \$1,035,000 to local units of government to update their comprehensive plans.

Known Support / Opposition

MetroCities has expressed support for development of a uniform process for managing the requests for deadlines extensions, but has expressed opposition to not allowing LCA grant agreements to be executed until plan updates are deemed complete for review.

RE: Request for Extension of Time to Complete Review and Amendment of Local Comprehensive Plans

Dear [NAME]:

Minnesota Statutes section 473.864 requires all metropolitan area units of government to review and, if necessary, amend their entire comprehensive plans, fiscal devices, and official controls at least once every ten years. This "decennial" review requirement ensures that comprehensive plans conform to metropolitan system plans and ensures that fiscal devices and official controls do not conflict with comprehensive plans or permit activities that conflict with metropolitan system plans. By statute, plan updates and amendments must be completed by December 31, 2008.

However, Minnesota Statutes section 473.864, subdivision 2, authorizes the Metropolitan Council to grant extensions to local governments that require additional time to complete their "decennial" review obligations and make necessary amendments to their comprehensive plans, fiscal devices, and official controls. At its ______, 2008 meeting, the Metropolitan Council adopted Resolution No. 2008-XX which states that local units of government may request an extension of the December 31, 2008, "decennial" review deadline to April 30, 2009, if the request includes a reasonably detailed timetable and plan for: (1) completing and submitting the comprehensive plan update to the Metropolitan Council, and (2) reviewing and amending fiscal devices and official controls.

If your city/township/county intends to request an extension, your local governing body must adopt a resolution requesting additional time and must provide a timetable and a plan for completion and submittal of the comprehensive plan update to the Metropolitan Council to no later than April 30, 2009. I have enclosed an extension request form that will provide the Metropolitan Council with information about your planning process so we can work directly with you on issues or conflicts you have identified to facilitate the completion of plan update. Also enclosed is a sample resolution. To have your request considered, the completed request form and accompanying resolution must be received at the Metropolitan Council offices by November 1, 2008. The Metropolitan Council will respond by letter to extension requests, indicating whether the request has been granted.

I would like to call your attention to some important guidelines which the Metropolitan Council has adopted that will apply if your community requests an extension to April 30, 2009:

- 1. Staff may administratively grant an extension to April 30, 2009 for submittal of the 2008 comprehensive plan update if (a) a community submits the extension request and required materials by November 1, 2008; and (b) the request includes a reasonably detailed timetable and plan for completing the review and amendment of the comprehensive plan update, the community's fiscal devices, and the community's official controls. The mandatory 6-month adjacent jurisdiction review process must be completed by that submittal date.
- 2. Communities identifying conflicts in forecasts or obstacles to plan completion may be asked to meet with Metropolitan Council staff and/or Metropolitan Council member(s) for their district to resolve outstanding issues.
- 3. If a comprehensive plan update cannot be submitted by April 30, 2009, with the mandatory 6-month adjacent community review complete, an extension of the submittal date will require action by the Metropolitan Council's governing body. A request for an extension of submittal beyond April 30, 2009

- will require submittal of the extension request documents and must be made by November 1, 2008. The local government representative must also make a presentation of the request directly to the Council's Community Development Committee at one of the Committee's regularly scheduled meetings.
- 4. After December 31, 2008, a community should not submit comprehensive plan amendments until the Metropolitan Council has acted on the community's 2008 comprehensive plan update.
- 5. An extension of the comprehensive plan completion deadline does not change any due dates for surface water plans or Critical Area/MNRRA plan funding agreements.
- 6. For LCA grants awarded after December 31, 2008, the Metropolitan Council will not execute an LCA grant agreement with any grantee community that has not submitted to the Council a comprehensive plan update that is complete for review.

WHEREAS, Minnesota Statutes section 473.864 requires local governmental units to review and, if necessary, amend their entire comprehensive plans and their fiscal devices and official controls at least once every ten years to ensure comprehensive plans conform with metropolitan system plans and ensure fiscal devices and official controls do not conflict with comprehensive plans or permit activities that conflict with metropolitan system plans; and

WHEREAS, Minnesota Statutes sections 473.858 and 473.864 require local governmental units to complete their "decennial" reviews by December 31, 2008; and

WHEREAS, Minnesota Statutes section 473.864 authorizes the Metropolitan Council to grant extensions to local governmental units to allow local governmental units additional time within which to complete the "decennial" review and amendments; and

WHEREAS, any extensions granted by the Metropolitan Council must include a timetable and plan for completing the review and amendment; and
