Proposed Action

That the Metropolitan Council extend the City's "decennial" comprehensive plan update submission deadline to May 29, 2009 subject to the following terms and conditions:

- 1. If the City submits a plan update to the Council by May 29, 2009 that is "complete" for review as defined in the Council's Local Planning Handbook and the adjacent review requirements have been completed by May 29, 2009, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 2. If the adjacent review requirements have not been completed by May 29, 2009 but the City submits a plan update to the Council by May 29, 2009 that otherwise is "complete" as defined in the Council's Local Planning Handbook, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 3. If the City has not submitted a plan update by May 29, 2009 that is "complete" as defined in the Council's Local Planning Handbook, the City must repay by July 30, 2009 all grant funds paid to the City under the grant agreement.
- 4. The grant agreement should be amended to: (a) extend the December 31, 2008 plan update submission deadline to May, 29, 2009; (b) reflect these terms and conditions; (c) make the execution of the grant amendment expressly conditioned on the City's acceptance of these terms and conditions; and (d) require a written bi-monthly progress report that describes in reasonable detail the City's progress toward meeting the May 29, 2009 deadline.

Background

In the request materials, the City of Corcoran indicated that staff workload and Planning Commission/City Council concerns contributed to the need to the requested extension. The City materials state that Corcoran has faced many challenges including transitioning from a rural community to one that will be receiving sewer for the first time, funding pressures and staff turnover. A new interim administrator was hired in January 2008. The City has had several months of planning sessions, but has faced challenges in channeling the public inputs. In addition, the City created comprehensive plan update subcommittees that meet monthly; however, more time is needed for these committees to work through comprehensive planning issues. These factors, as well as the need for additional professional planning assistance for the comprehensive plan, along with vigorous public participation have placed the City a year behind in its comprehensive plan update process. The City indicates that the draft of the comprehensive plan will be complete by early April 2009, with the adjacent community and affected jurisdiction review being initiated by April 23, 2009. The 6-month review period would then be complete in mid-October, allowing the community time to make any necessary changes and the City Council to take action to submit the plan to the Council by December 29, 2009.

May 2007 Council Action. In May 2007, the Council authorized staff to implement a local planning assistance grant program to help ensure qualifying local governments and counties could prepare and submit their "decennial" comprehensive plan updates to the Council by the statutory December 31, 2008 deadline.

<u>Grant Agreement</u>. The City was awarded a \$20,000 Local Planning Assistance Program grant in August 2007. The grant agreement requires the City to:

- 1. review and update its comprehensive plan by December 31, 2008;
- 2. submit its draft plan update to adjacent governmental units by June 30, 2008;
- 3. discuss its draft plan with watershed management organizations;
- 4. submit a "complete" plan as described in the Council's Local Planning Handbook; and
- 5. ensure its plan conforms with the Council's metropolitan system plans.

The grant agreement further provides that if the City does not comply with the terms and conditions of the agreement, "the Council may take any action to protect its interests and may require the [City] to return all or part of the [grant] funds."

<u>December 31, 2008 Deadline</u>. Minnesota Statutes section 473.864 requires local governmental units to review and, if necessary, amend their entire comprehensive plans on a decennial basis. The current "decennial" review deadline is December 31, 2008. Section 473.864 authorizes the Council to grant extensions to local governmental units to allow those units additional time to review and, if necessary, amend their comprehensive plans. The extensions must include a timetable and plan for completing the plan review and amendment.

<u>June 2008 Council Action</u>. On June 25, 2008, the Council adopted guidelines for granting requests to extend the "decennial" plan update submission deadline. Subject to certain conditions, the guidelines authorized staff to "administratively" grant extensions to May 29, 2009. If plan updates and adjacent reviews could not be completed by May 29, 2009, the guidelines state that extension requests require action by the Council's governing body.

Rationale

Local comprehensive plan updates can be challenging for cities, particularly cities that are experiencing (or are expected to experience) significant land use changes. Some cities have limited resources to meet these types of planning challenges and public input processes sometimes can be very time consuming. The City of Corcoran is working on a draft of its comprehensive plan, has had numerous open houses, comprehensive plan subcommittees that meet monthly, and recently retained an additional consulting planner to help complete the comprehensive plan. The City's request for an extension to December 29, 2009 is seven months beyond that which could be administratively reviewed to allow completion of the City's plan and then to accommodate a full six-month adjacent review period. However, the City contractually agreed to perform and complete certain statutorily required planning activities but failed to fulfill those agreements.

Staff recommends that the Metropolitan Council extend the City's "decennial" update submission deadline to May 29, 2009 subject to the following terms and conditions:

- 1. If the City submits a plan update to the Council by May 29, 2009 that is "complete" for review as defined in the Council's *Local Planning Handbook* and the adjacent review requirements have been completed by May 29, 2009, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 2. If the adjacent review requirements have not been completed by May 29, 2009 but the City submits a plan update to the Council by May 29, 2009 that otherwise is "complete" as defined in the Council's *Local Planning Handbook*, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 3. If the City has not submitted a plan update by May 29, 2009 that is "complete" as defined in the Council's *Local Planning Handbook*, the City must repay by July 30, 2009 all grant funds paid to the City under the grant agreement.

4. The grant agreement should be amended to: (a) extend the December 31, 2008 plan update submission deadline to May, 29, 2009; (b) reflect these terms and conditions; (c) make the execution of the grant amendment expressly conditioned on the City's acceptance of these terms and conditions; and (d) require a written bi-monthly progress report that describes in reasonable detail the City's progress toward meeting the May 29, 2009 deadline.

Funding

Corcoran was one of 49 communities to receive a local planning grant from the Council. Half of the \$20,000 grant money has already been awarded, pursuant to the terms of the grant. The remaining \$10,000 is due to be awarded upon completion of the plan update, with the condition that it be submitted by December 31, 2008 as indicated in Section 2.01 of the planning grant agreement. The grant agreement allows for amendment of the agreement, including amending the plan update submission deadline. It is reasonable to agree to amend the planning grant agreement plan submission deadline to May 29, 2009.

In addition, the Metropolitan Council provided the City with a \$40,000 Planning Assistance Loan (L-2006-13).

The City of Corcoran is working on the draft of its 2030 Comprehensive Plan. We have been working aggressively on our plan update. We feel that in 2008 there were significant gains in the update process through citizen participation. We now have a professional planner to help implement change.

Once the Planning Consultant finalizes all of the collective comments and ideological ideas, a draft document can be presented to Planning Commission, Parks and Trails Commission and the City Council. Extension Need/Purpose

Corcoran faces many challenges. We are a diverse community with a large commuter population, no municipal water and sewer services, five school districts, and three zip codes. Building a focused, unified community is a recognized challenge. We are also experiencing rocketing land prices. The MUSA system has reached our eastern border and our opportunities are present and substantial. This is a critical time for the future of Corcoran.

As describe below, the community created a long range Comprehensive Plan between 1998 and 2002. However, we have lacked continuity in both our elected officials and city support staff, and we continue to struggle with implementation. We recognize that the best planning efforts can't achieve our vision without sustainable implementation strategies and the policies, procedures, and ordinances that will keep us moving forward. Corcoran currently uses a contract Planner who works on day-to-day zoning and project specific efforts/ we elect or re-elect a majority of our city council every two years, creating a real challenge to policy continuity and the level of elected official experience. Corcoran would benefit greatly from sustained professional planning assistance and implementation guidance.

Corcoran received a Met Council planning grant for the local surface water management plan that is required as part of the 2008 update. The local surface water management plan is nearly complete.

Corcoran is not wary of professional assistance. We understand that we can benefit from help, especially in the process of planning and implementation. We are a community with values and goals. We are a community that will protect our values and retain our identity in the future. We understand that our future is destined to include population and infrastructure changes and growth. Corcoran wants to retain its unique beauty, resources, and green space, while embracing the future.

Community visioning

Corcoran began a "growth management" visioning effort in 1998. The effort was coordinated primarily by community volunteers with limited professional assistance. The volunteers worked in four committees: land use and zoning, waste-and surface-water planning, transportation, and natural resources. This was an effort in preparation for the Corcoran's first comprehensive plan. While volunteer effort was informative and beneficial, the lack of professional planning assistance made it very difficult to articulate planning policies and implementation tools.

Corcoran was able, generally during the period from 2000 to 2002, to translate its initial visioning process into the current Comprehensive Plan. The period of 2002 to 2004 saw a greater emphasis on developing implementation tools. Corcoran would greatly benefit form a renewed community visioning process. We lack the current ability to determine whether core community values have shifted, remained unchanged, or are adequately reflected in our land use plan and implementation tools and strategies.

We are attempting to update and extend our 2020 Comprehensive Plan to the year 2030, consistent with Met Council mandates. We have been working without planning assistance to where the process has been delayed. We have experienced and continue to receive tremendous citizen input and ideas. Our

challenge is to channel that community energy into a meaningful policy document that will guide us to a future we all accept and support.

We attempted a community survey in 2005 but had an extremely low response rate, and the results have not been incorporated into our city hall discussions in any meaningful way. We recognize the potential benefits of a community survey tool, but have lacked the professional resources to prepare, circulate, and interpret a credible survey.

Our city communications effort has been sporadic due to funding pressures and staff turnover. We have historically prepared a quarterly city newsletter, addressing multiple topics, but a newsletter hasn't been possible this year due to funding cuts and loss of city staff. Our community website has not been updated in a timely manner due to the same constraints. We would greatly benefit from a consistent, easily accessible forum for communication to our residents.

Corcoran is a passionate community with a demonstrated history of citizen participation and volunteerism in public processes. We have regular attendance of 20-30 citizens at our city council meetings. We have held open houses and workshops on a variety of matters, all of which were very well attended. We have had several months of comprehensive planning "open mike" sessions having attendance in excess of 100 citizens. We hope to capitalize on this pattern of citizen involvement as we work toward our Comprehensive Plan update.

Corcoran's challenge is to channel all our inputs into a comprehensive plan with implementation tools that are real and tangible for the immediate, mid-term, and long term future.

Recently the City Council implemented a work committee consisting of members of the city council, planning commission, parks and trails commission and citizens at large. There are two general focus areas—one focusing on Land Use while the other focuses on the collective topics of Infrastructure/Transportation/Natural Resources. Each of these Subcommittees meets monthly.

Community Growth Options Planning Grant

Earlier it was mentioned that the City received a Community Growth Options Planning Grant in September 2008 from 1000 Friends of Minnesota. The grant is significant enough to where we have hired a professional planning firm to work with Corcoran in implementing the 2030 Comprehensive Plan.

Implementation

However, we still need the time and that is why we are asking for this extension. Rest assured, with the community due diligence and new found professional planning help, this will get implemented and reviewed positively by our neighboring communities.

Corcoran and its citizens, commissions and planning consultant team are continuing to work aggressively on the comprehensive plan update. Our professional planner is working closely with our city engineer and knowing once all the elements are agreed upon, each chapter and associated mapping will pull together swiftly.

The overall delays from not having professional help, along with vigorous public participation has placed the city a year behind in its update process. Nonetheless, we feel with the efforts from the volunteers and the new found professional planning help, we feel confident that a draft of the entire comprehensive plan can be approved by the City Council on April 2009. We anticipate a few weeks of

production work after Council approval of the draft. This would allow us to distribute the approved draft to other agencies for their review towards the end of April 2009. After the six month review period, the Corcoran City Council could then hold a hearing and submit the plan to the Metropolitan Council on December 29, 2009.

RESOLUTION REQUESTING ADDITIONAL TIME WITHIN WHICH TO COMPLETE COMPREHENSIVE PLAN "DECENNIAL" REVIEW OBLIGATIONS

WHEREAS, Minnesota Statutes section 473.864 requires local governmental units to review and, if necessary, amend their entire comprehensive plans and their fiscal devices and official controls at least once every ten years to ensure comprehensive plans conform with metropolitan system plans and ensure fiscal devices and official controls do not conflict with comprehensive plans or permit activities that conflict with metropolitan system plans; and

WHEREAS, Minnesota Statutes sections 473.858 and 473.864 require local governmental units to complete their "decennial" reviews by December 31, 2008; and

WHEREAS, Minnesota Statutes section 473.864 authorizes the Metropolitan Council to grant extensions to local governmental units to allow local governmental units additional time within which to complete the "decennial" review and amendments; and

WHEREAS, any extensions granted by the Metropolitan Council must include a timetable and plan for completing the review and amendment; and

WHEREAS, the City will not be able to complete its "decennial" review by December 31, 2008, for the following reasons: Lack of Professional help to accomplish its implementation.

WHEREAS, the City Council finds it is appropriate to request from the Metropolitan Council an extension so the City can have additional time to complete and submit to the Metropolitan Council for review an updated comprehensive plan and amend its fiscal devices and official controls.

NOW, THERFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CORCORAN, MINNESOTA, AS FOLLOWS:

- The City Administrator is directed to submit to the Metropolitan Council no later than November 1, 2008, an application requesting an extension to December 29, 2009.
- The City Administrator must include with the request a reasonably detailed timetable and plan for completing: (a) the review and amendment by December 29, 2009; and (b) the review and amendment of the City's fiscal devices and official controls.
