Proposed Action

There is no action or direction requested from the Committee. The purpose of this report is to provide information about the community engagement approach developed and implemented through the Corridors of Opportunity by introducing the members of the Community Engagement Team and three organizations' leaders that received grants for their engagement work around land use and transitway topics along transitway corridors. In addition, the Committee will be briefed about how the lessons learned through this grass roots community based engagement work from the Corridors of Opportunity is being integrated into the Thrive MSP 2040 outreach and engagement process.

Background

<u>Corridors of Opportunity.</u> The HUD Sustainable Communities Grant prioritized \$750,000 for engaging underrepresented communities (low income, new immigrant communities, communities of color and persons with disabilities - including disabled seniors) in the land use and transitway planning process. The grant identified a Community Engagement Team (CE Team), whose members include:

Repa Mekha, Nexus Community Partners

Russ Adams, the Alliance for Metropolitan Stability

Margaret Kaplan, now Ned Moore, the Minnesota Center for Neighborhood Organizing, CURA

The CE Team worked with community based organizations, who work with underrepresented communities, to develop a grant program for community engagement around any of seven transitways (Northstar, Central, Hiawatha, Bottineau, Gateway, Cedar and Southwest). In October, 2011 the first round of engagement grants of \$393,000 were awarded by the Corridors of Opportunity Policy Board to community based organizations, many of them working collaboratively. The average grant was

\$ 30,000. The second round of grants will be awarded in September 2012 for \$323,000.

<u>Thrive</u>: The connections established between the Metropolitan Council and other government staff and the community based organizations that received grants has resulted in more opportunities to work together. Building on these relationships with the Community Engagement Steering Committee, about 90 community based organizations, the Metropolitan Council staff invited these leaders to participate in two small group listening sessions around Thrive MSP 2040 on August 14, 2012 in community locations. Fifteen participants attended each of the two sessions. Communities represented included Native American, Hmong, Laotian, Latino, Somali, Ethiopian, African American, persons with disabilities, potential small business entrepreneurs and white.
