"That the meeting be closed pursuant to Minnesota Statutes section 13D.05, Subd. 3(b), so the Council could discuss matters, in anticipation of litigation, which are subject to the attorney – client privilege in connection with the bus procurement involving Gillig and the protest by New Flyer."

Chair Bell led the discussion, stating:

- the Council may be a majority vote in a public meeting, decide to hold a closed meeting when there is a need to discuss, confidentially, matters which are subject to the attorney-client privilege.
- the discussion at this closed meeting will NOT be tape-recorded.
- discussions at this closed meeting must be limited to discussions related to anticipated or threatened litigation, pending litigation or other adversarial legal proceedings, legal strategies, settlements and resolutions and legal consequences of specific acts. No other public business may be discussed or transacted at this closed meeting.
- if this meeting is closed, the closed meeting will occur in these chambers immediately after the vote to close the meeting.

A vote was taken on the motion and carried.

Everyone was asked to leave the room except Council members, Council staff, attorneys and others whose presence is necessary for a confidential discussion of the privileged matters.

The meeting was then closed at 4:15 p.m.
