# **Summary of Committee Discussion:**

Staff responded to questions about the application, process and notification to eligible communities.

#### Recommendation:

Council staff recommends that the Metropolitan Council take the following actions:

- 1. Authorize staff to implement a local planning assistance grant program to make grants available to qualifying local governments and counties to prepare and submit comprehensive plan updates to the Metropolitan Council by December 31, 2008.
- 2. Authorize that eligible applicants for this grant program be:
  - a. Communities with a 2005 Net Tax Capacity (NTC) amount less than or equal to 300 percent of the median NTC (\$12,840,000) for all communities in the metropolitan area. and.
  - b. With a forecasted household growth for 2010 to 2030 that is a percent growth equal to or greater than the median (21) percent of forecasted household growth.
  - c. Be a county, or a consortium of at least five communities working collaboratively to update their local comprehensive plans.
- 3. Authorize the Community Development Director to sign the grant agreements for this program.

#### **BACKGROUND**

The Metropolitan Land Planning Act authorizes the Council to establish a planning assistance fund to make grants and loans to local governments to assist in preparation of local comprehensive plans (473.867 Planning Assistance; Grants; Loans).

Attached is a summary of the framework for a local planning assistance grant program to make grants available to qualifying local governments and counties to prepare and submit comprehensive plan updates to the Metropolitan Council by December 31, 2008.

This information has been presented and discussed with the CDC on January 16, 2007, and February 5, 2007.

#### **ISSUES**

The Minnesota House of Representatives has not yet passed the legislation that will allow the Council to transfer \$1 million from the Livable Communities Demonstration Account (LCDA) to the Local Planning Assistance Fund. However, in order to prepare materials and communications associated with this planning assistance effort in a timely manner once the Governor signs the legislation into law, staff is seeking concurrence by the Council with the construct for the 2007 program. Final action to authorize the program by the Council will not be sought until the Governor signs the legislation into law, and the Council amends the budget to transfer the funds from the LCDA to the Planning Assistance Fund.

### PROPOSED ACTION

Council staff recommends that the Metropolitan Council take the following actions:

- 1. Authorize staff to implement a local planning assistance grant program to make grants available to qualifying local governments and counties to prepare and submit comprehensive plan updates to the Metropolitan Council by December 31, 2008.
  - a. Authorize that eligible applicants for this grant program be:
- 2. Communities with a 2005 Net Tax Capacity (NTC) amount less than or equal to 300 percent of the median NTC (\$12,840,000) for all communities in the metropolitan area.

and,

- a. With a forecasted household growth for 2010 to 2030 that is a percent growth equal to or greater than the median (21) percent of forecasted household growth.
- b. Be a county, or a consortium of at least five communities working collaboratively to update their local comprehensive plans.
- 3. Authorize the Community Development Director to sign the grant agreements for this program.

#### 2007 PLANNING ASSISTANCE GRANT FRAMEWORK

The Council has indicated a preference for distributing the funding assistance to small communities with limited budgets and staff.

Council staff considered "need" based on NTC, and percent household growth from 2010 to 2030 to identify those communities having comparatively low property values, but with forecasts for substantial household growth given their current household numbers.

The Council will provide a grant - 50 percent of the grant upon review and execution of the grant agreement and the remaining 50 percent following the Council's action on the plan – to applicants that agree to the following requirements:

- 1. Meet Council grant agreement requirements that require the applicant to provide a work plan that identifies the eligible grant funding activities for which the grant funds will be used as set forth in Minn. Stat. §473.867, subd. 6, Assistance for plan updates.
- 2. Submit a plan update which:
  - a. is received no later than December 31, 2008;
  - b. includes complete information to meet content requirements set forth in Minn. Stat. §473.859;
  - c. conforms with metropolitan system plans as defined in Minn. Stat. §473.852, subd. 8.
- Distribute a draft plan for adjacent local government review by June 30, 2008.
   (473.858, subd. 2 requires local governments to submit draft plans to adjacent governmental units and affected school districts for review and comment at least six months prior to submitting the
  - plan to the Council.)
- Discuss a draft plan with Council sector representatives twice to update the Council on plan progress or potential policy conflicts prior to circulating the plan to adjacent units of government.
- 5. Discuss a draft plan with the appropriate watershed management organizations for local surface water management plan requirements.

# **Proposed Grant Amounts**

The application of "need" based on NTC and percent household growth increase, results in a list of 47 eligible communities, townships and cities where their county does not prepare their comprehensive plans (see attached table).

Of these, 11 are unsewered communities and 36 are sewered communities. In addition, three counties, Carver, Dakota and Scott, are eligible counties/consortiums for assistance may result in preparation of plans for 23 townships. In total, 70 communities may be assisted by grants from this program.

Sewered communities will receive a larger grant than unsewered communities because of the additional planning requirements they face. The counties will receive a larger amount for preparing plans for their townships.

# POTENTIAL TECHNICAL ASSISTANCE ALTERNATIVE

Several communities have a low net tax capacity (NTC) and very little or no forecasted 2010 to 2030 household growth. To these communities, the Council expects to be able to offer assistance in preparation of their comprehensive plan updates through the use of the Council's Electronic Content Management System being implemented in 2007.

By using the available software, Council staff may be able to electronically scan the 1998 plans. Once scanned, Council staff, with city input, can review the document and identify information that needs to be changed to meet current content requirements. The software redacts specific numbers or wording that need to be updated, amended or expanded to meet the 2030 planning requirements.


This assistance would significantly limit the amount of work and cost for communities that have relatively few and minor changes from the current, 1998 comprehensive plan.

The following communities with zero or one percent forecasted household growth to 2030, with a low net tax capacity, would potentially be eligible for this technical assistance.
