# Project Schedule History – 2007

- March 2007 MnDOT and BNSF executed Purchase and Sale Agreement
- March 2007 NCDA paid BNSF \$10M
- April 2007 FTA issued LONP for locomotives
- April 2007 Met Council executed contract for locomotives
- May 2007 NCDA paid BNSF \$24M
- May 2007 Met Council and BNSF executed Joint Use Agreement and Commuter Services Agreement
- May 2007 Northstar funding partners approved budget of \$320M
- June 2007 FTA issued LONP for construction contracts #1 and #2
- June 2007 MnDOT awarded construction contract #1 downtown Mpls.

# Joint Use Agreement


Met Council is responsible for:

- Maintaining all "rolling stock"
- Maintaining stations and platforms
- Providing passenger security
- Establishing and collecting fares
- Marketing
- Customer relations

- Ballpark pays to realign BNSF tracks
- Ballpark pays to extend Northstar storage
