Acquisition Opportunity Grant Request, reimbursement consideration in a future parks CIP and boundary amendment for Lake Waconia Regional Park, Carver

Subject: County

Summary of Committee Discussion: This item is being forwarded to the Metropolitan Council without recommendation due to the lack of a quorum at the July 16th, 2007 Community Development Committee meeting.

Recommendation:

That the Metropolitan Council:

1. Authorize a grant of up to \$400,841 from the Park Acquisition Opportunity Fund to Carver County to partially fund the acquisition of the Park/highway parcel in Lake Waconia Regional Park.
2. Allow up to \$601,263 of the acquisition costs of the Park/highway parcels to be eligible for reimbursement consideration in a future regional parks CIP. However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.
3. Approve a modified park boundary for Lake Waconia Regional Park as shown in Attachment 2 as an amendment to the 2001 Council approved master plan for the park, and direct staff to modify any acreage data for the park.

Proposed Action/Motion

That the Metropolitan Council:

1. Authorize a grant of up to \$400,841 from the Park Acquisition Opportunity Fund to Carver County to partially fund the acquisition of the Park/highway parcel in Lake Waconia Regional Park.
3. Allow up to \$601,263 of the acquisition costs of the Park/highway parcels to be eligible for reimbursement consideration in a future regional parks CIP. However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.
3. Approve a modified park boundary for Lake Waconia Regional Park as shown in Attachment 2 as an amendment to the 2001 Council approved master plan for the park, and direct staff to modify any acreage data for the park.

Issue(s)

- Should the Metropolitan Council approve a grant of up to \$400,841 from the Council's "Acquisition Opportunity Funds" to Carver County to partially fund the acquisition of the 43.93 acre Park/highway property at Lake Waconia Regional Park?
- Is \$601,263 of regional park acquisition costs eligible for reimbursement with a Metropolitan Council grant in a future regional parks capital improvement program?
- Should the Metropolitan Council approve a boundary amendment for Lake Waconia Regional Park?

Overview and Funding

The Lake Waconia Regional Park master plan, which was approved by the Metropolitan Council in October 2001, called for the relocation of State Highway 5 to facilitate development of the park. The highway dissected the park, so a portion of the highway was relocated south of the park. Due to disagreements on the value of the land for the new right-of-way for State Highway 5 and the land where the former Highway 5 right-of-way was located, Carver County and the landowners entered condemnation proceedings to determine the value of the land. Additionally, the County undertook condemnation proceedings because \$5 million of Federal Surface Transportation Project Funds for construction of the relocated highway were in jeopardy if land for the highway right-of-way was not acquired by September 30, 2005.

The Metropolitan Council authorized a grant of \$83,060 from the emergency land acquisition fund (now known as the acquisition opportunity fund) to Carver County at its August 11, 2004 meeting. This grant funded 40 percent of the County's total costs incurred at that time for the Park/highway property. As part of the grant authorization, the Council also acted to:

Inform Carver County that the Council will consider other emergency land acquisition grant(s) for this land based on actual costs determined from the results of condemnation proceedings.

Condemnation proceedings have now been completed. Carver County has incurred costs totaling \$2,337,671.82 for the Park/highway property. With land costs of \$2,292,416.89 for 43.94 acres, the average price per acre of property is \$52,172. The County has used funds from five previous grants totaling \$1,335,540.44 to partially fund this acquisition. Therefore, the funding gap is \$1,002,104.

The 2006-07 *Regional Parks CIP* allows for funding of up to 40% of the purchase costs of a property in the Regional Park System through the Park Acquisition Opportunity Fund. The County's request for up to \$400,841 reflects 40% of the remaining grant eligible purchase costs. Carver County also requested that up to \$601,263 financed with County funds be eligible for reimbursement consideration in a future regional parks CIP.

The Metropolitan Council has granted \$6,663,695 to-date from the Park Acquisition Opportunity Fund. The balance in the Fund prior to granting any funds for acquisition of the Park/highway parcels is \$2,449,001. If \$400,841 of acquisition opportunity funds were granted for the Park/highway parcels, there would be \$2,048,160 remaining in the Fund for future land acquisition.

Carver County initially intended to purchase 39.04 acres for this portion of the park and the highway right-of-way. The County opted to purchase 43.94 acres because the configuration of the road and park boundaries made the remnants of the land economically unfeasible to develop. Additionally, the severance damages would have cost the County nearly the same amount of money as buying the additional land. Therefore, the County is requesting that the park boundary be amended to include the remnant land adjacent to the park.

The Metropolitan Parks and Open Space Commission reviewed the acquisition opportunity grant, reimbursement consideration and boundary amendment requests at its July 10, 2007 meeting. The Commission unanimously approved the recommendations.

INTRODUCTION:

The Lake Waconia Regional Park master plan, which was approved by the Metropolitan Council in October 2001, called for the relocation of State Highway 5 to facilitate development of the park. The highway dissected the park, so a portion of the highway was relocated south of the park. Due to disagreements on the value of the land for the new right-of-way for State Highway 5 and the land where the former Highway 5 right-of-way was located, Carver County and the landowners entered condemnation proceedings to determine the value of the land. These parcels, which make up 43.94 acres of land, will be hereafter referred to as the "Park/highway property."

The Metropolitan Council authorized a grant of \$83,060 from the emergency land acquisition fund (now known as the acquisition opportunity fund) to Carver County at its August 11, 2004 meeting. This grant funded 40 percent of the County's total costs incurred at that time for the Park/highway property. As part of the grant authorization, the Council also acted to:

Inform Carver County that the Council will consider other emergency land acquisition grant(s) for this land based on actual costs determined from the results of condemnation proceedings.

The County undertook condemnation proceedings because \$5 million of Federal Surface Transportation Project Funds for construction of the relocated highway were in jeopardy if land for the highway right-of-way was not acquired by September 30, 2005.

Condemnation proceedings have now been completed. Carver County has spent a total of \$2,337,672 for the land and associated acquisition costs for the Park/highway property. The County has used \$1,335,568 of funds from five previous grants, including the grant described above, to partially fund the acquisition. Thus, the funding gap between the total costs and grant funds used is \$1,002,104. The County has requested that up to \$400,841 be granted from the Metropolitan Council's Park Acquisition Opportunity Fund to finance 40 percent of the funding gap. The County has also requested that up to \$601,263 financed with County funds for the remaining 60 percent be eligible for reimbursement consideration in a future regional parks CIP. (See **Attachment 1**, letter from Martin Walsh, Carver County Parks Director)

Carver County initially intended to purchase 39.04 acres for this portion of the park and the highway right-of-way. The County opted to purchase 43.94 acres because the configuration of the road and park boundaries made the remnants of the land economically unfeasible to develop. Additionally, the severance damages would have cost the County nearly the same amount of money as buying the additional land. The County is requesting a master plan amendment to the boundary of Lake Waconia Regional Park to include this land, which is contiguous to the park. (See **Attachment 2**, Current and Proposed Park Boundaries).

This memorandum analyzes the request against the criteria for granting acquisition opportunity funds and recommends approving a grant of up to \$400,841. It also analyzes the request for reimbursement consideration and recommends that up to \$601,263 be eligible for reimbursement consideration in a future regional parks CIP. Finally, it recommends amending the master plan boundary of Lake Waconia Regional Park.

AUTHORITY TO REVIEW:

Minnesota Statute Section 473.315 authorizes the, “Metropolitan Council, with the advice of the Metropolitan Parks and Open Space Commission, to make grants from any funds available to it for recreation open space purposes to any municipality, county or Park District located wholly or partially within the metropolitan area to cover the cost, or any portion of the cost, of acquiring or developing regional recreation open space in accordance with the *Regional Recreation Open Space Policy Plan*”.

ANALYSIS:

ACQUISITION OPPORTUNITY FUND GRANT REQUEST

Carver County has incurred costs totaling \$2,337,671.82 for the Park/highway property. With land costs of \$2,292,416.89 for 43.94 acres, the average price per acre of property is \$52,172. The breakdown of the total costs is shown below.

The Metropolitan Council has granted \$6,663,695 to date from the Park Acquisition Opportunity Fund as shown in Table 2.

Based on the 2006-07 regional parks CIP, five conditions govern the use of the Park Acquisition Opportunity Fund, which are indicated below in bold. The following findings indicate that these conditions have been met for the Carver County request to acquire the Park/highway parcels in Lake Waconia Regional Park.

1. The land in question is consistent with a Council approved park/trail master plan.

The acquisition of this land for Lake Waconia Regional Park is consistent with the Council approved park master plan, which was approved in October, 2001.

2. The land is under threat of loss for park uses because it is for sale. Action is needed now to acquire it versus waiting for future State appropriations/matching Council funds to acquire it later.

Carver County had secured \$5 million in Federal Surface Transportation funds to construct the new section of Highway 5. These funds were in jeopardy if the land for the right-of-way was not acquired by September 30, 2005. The County initiated condemnation proceedings and requested an emergency acquisition grant in 2004 for the Park/highway parcels. At that time, it was unknown what the final purchase price of the land would be, so the Council informed the County that it would consider another emergency acquisition grant (now known as an acquisition opportunity grant) once the actual costs were determined as a result of the condemnation proceedings.

3. The park agency that wants to buy the land has no other park CIP grants available to buy it.

Carver County does not have any CIP acquisition grant funds available that have not already been applied and fully committed to this project.

4. The grant from the Park Acquisition Opportunity Fund may finance up to 40% of the fair market value of the parcel and related acquisition costs (appraisals, tax equivalency payments, relocation, and stewardship costs—well capping, demolition/removal of hazardous structures, etc.) The remaining 60% match can be either provided by the park agency in cash, or other matching funds such as a watershed district grant, or the land seller can reduce the sale price of the parcel by 60%. A combination of park agency cash, matching funds and a reduced sale price can be used to finance

the remaining 60%. The park agency can request to be considered for reimbursement of its cash contribution in a future regional parks CIP.

Carver County has requested \$400,841 for the Park/highway parcels, which is 40% of the total remaining acquisition costs that have not been funded with previous grants. The County is financing the remaining 60% with County funds and has requested reimbursement consideration of these funds in a future regional parks CIP.

5. **No more than \$1 million may be granted from the Fund to a regional park agency from July 1, 2007 to whenever any change in the amount and the timeline of the revised rules are adopted by the Metropolitan Council.** (this revised provision was adopted by the Metropolitan Council at its June 27, 2007 meeting)

This is the first request from Carver County for an Acquisition Opportunity Grant since July 1, 2007. The request of \$400,841 is consistent with the policy limit of \$1 million per agency for acquisition opportunity funds granted from July 1, 2007 to whenever any change in the amount and the timeline of the revised rules is adopted by the Metropolitan Council.

Status of remaining acquisition opportunity funds:

If \$400,841 is granted, there would be \$2,048,160 remaining for future acquisition opportunities as shown in Table 4.

REIMBURSEMENT CONSIDERATION IN A FUTURE PARKS CIP REQUEST

As noted above, Carver County has requested eligibility for reimbursement consideration of up to \$601,263 in a future regional parks CIP to acquire this parcel. The request must comply with the terms of Strategy 2(f) of the *2030 Regional Parks Policy Plan* regarding reimbursement eligibility to acquire land. The applicable excerpts from that policy states:

Strategy 2(f): Reimbursement

Reimbursement will be considered for early acquisition of land currently designated as regional recreation open space by the Metropolitan Council in the *2030 Regional Parks Policy Plan* if the acquisition is in full agreement with a Council-approved master plan as required under MN Statutes 473.313 and the regional park implementing agency received Council approval prior to undertaking the acquisition.

...

If these conditions are met as required by MN Statutes 473.147, and 473.313 the Council will consider reimbursing the park agency via a grant as permitted under MN Statutes 473.315 for the following costs:

- a) Appraisal costs incurred by the acquiring park agency or entity under contract with the agency
- b) Surveying costs incurred by the acquiring park agency or entity under contract with the agency
- c) Legal fees incurred by the acquiring park agency or entity under contract with the agency
- d) Fees for service provided by an entity under contract by the park agency to negotiate and purchase the land or obtain an option to purchase
- e) Principal payments made towards the purchase price including principal payments on a contract for deed or bond, or payments made on an option to purchase
- f) 180% of township or city taxes due on the parcel at the time of closing as required by MN Statute 473.341

...

The Metropolitan Council will use best efforts to implement this reimbursement policy as described above. However, the Council does not, under any circumstances, represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

Acquisition of land for the realignment of Highway 5 is consistent with the Council approved master plan for Lake Waconia Regional Park. The County took legal right to the property in 2004 in order to facilitate road construction; however, the purchase price of the properties was not determined until the end of the condemnation proceedings. Closing dates for the properties varied from December of 2006 to May 2007. Due to the complexity of these transactions, the tax equivalency payments were not finalized until June 2006. The County brought this request to the Council in May 2006. Instead of processing this request prior to having the final total costs and having to come back to the Council again, this request was held until all of the costs were calculated.

AMENDMENT OF MASTER PLAN PARK BOUNDARY REQUEST

AUTHORITY TO REVIEW

Minnesota Statute Section 473.313 subdivision 1 requires regional park implementing agencies to prepare, and from time to time revise and resubmit to the Metropolitan Council a master plan and annual budget for the acquisition and development of regional recreation open space that is managed by that park agency. Subdivision 2 of this statute authorizes the Metropolitan Council to review with the advice of the Metropolitan Parks and Open Space Commission each master plan to determine whether it is consistent with the Metropolitan Council's park policy plan and other applicable Council policy plans. If the master plan is not consistent with Metropolitan Council policy plans, the Metropolitan Council shall return the plan to the park agency with its comments for the agency to revise and resubmit the plan. .

ANALYSIS

As noted in the "Background" section of this staff report, Carver County purchased 43.94 acres for this portion of Lake Waconia Regional Park and the highway right-of-way, instead of 39.04 acres. The extra acreage was acquired as part of a parcel needed for highway construction that would not have been developable if partitioned from the original property. This extra acreage is contiguous to the park's original boundaries.

Park grants have been used to partially finance acquisition of the Park/highway property, including the extra acreage. Therefore, it is reasonable to amend the park boundary to add this property to the master plan boundary for Lake Waconia Regional Park.

CONCLUSIONS:

1. Carver County's request of \$400,841 in Park Acquisition Opportunity Funds to acquire the Park/highway parcels in Lake Waconia Park Reserve is consistent with the conditions for receiving a grant from the Park Acquisition Opportunity Fund.
2. Carver County's request to be eligible for reimbursement consideration of up to \$601,263 in a future regional parks CIP is consistent with the conditions of Strategy 2(f) Reimbursement, in the *2030 Regional Parks Policy Plan*.
3. The park boundary for Lake Waconia Regional Park should be modified to include the extra property acquired as part of the Park/highway parcels.

RECOMMENDATIONS:

That the Metropolitan Council:

1. Authorize a grant of up to \$400,841 from the Park Acquisition Opportunity Fund to Carver County to partially fund the acquisition of the Park/highway parcel in Lake Waconia Regional Park.
4. Allow up to \$601,263 of the acquisition costs of the Park/highway parcels to be eligible for reimbursement consideration in a future regional parks CIP. However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.
3. Approve a modified park boundary for Lake Waconia Regional Park as shown in Attachment 2 as an amendment to the 2001 Council approved master plan for the park, and direct staff to modify any acreage data for the park.

The condemnation proceedings for property needed for Lake Waconia Regional Park and to relocate TH 5 out of the park boundary has been completed.

On August 11, 2004 the Metropolitan Council approved an emergency land acquisition grant for Carver County to acquire land needed for Lake Waconia Regional Park and new alignment of TH 5. In addition, the Council informed Carver County that it will consider other emergency land acquisition grant(s) for this land based on actual costs determined from the results of condemnation proceedings and if there are no regional park CIP funds provided to the County for acquiring Land for Lake Waconia Regional Park.

Carver County has incurred an additional \$1,002,104.38 in land acquisition costs related to the acquisition of 43.94 acres. The County is requesting a Land Acquisition Opportunity Grant of \$400,841.75 which is 40 percent of the actual expenses. The County will seek reimbursement for the remaining balance of the acquisition costs of \$601,262.63 in a future CIP request to the Council.

A summary of grant activity and funding by Carver County is attached. The total land cost for the 43.94 acres is \$2,292,416.89. The cost per acre is \$52, 171.53. Other costs related to the acquisition totaled \$45,227.93.

In addition, Carver County is also requesting a master plan amendment to the Lake Waconia Regional Park boundary. Additional land was needed for the TH 5 road construction project and uneconomic remnants of parcels damaged by acquisition were also acquired. Land that was acquired for the project and contiguous to the park is recommended for inclusion within the park boundary. Please see the attached exhibit.
