<u>2007-9 - City of Orono Comprehensive Plan Amendment, Myrtlewood, Review File 18392-5</u> It was moved by Wolter and seconded by Sanda

# <u>2007-14 - Metropolitan Urban Service Area (MUSA) Implementation Guidelines</u>

It was moved by Wolter and seconded by Sanda

"That the Metropolitan Council adopt the following guidelines:

1. a) Cities that have participated in the Council's Plat Monitoring Program beginning in 2000 or submit the necessary plat data from 2000 will be credited on a 1:1 basis for

housing units platted or developed that yield an overall average density in excess of 3 units per net developable acre. The housing unit credits will be applied to areas guided for 2020-2030 urban services and to any other proposed reguided areas. The combined overall average density needs to be a minimum of 3 units per net developable acre based on an acreage average of the city's actual development and platting since 2000, the lowest allowable density in 2020-2030 guiding, and any reguided land.

- b) Without development history from 2000, the Council will use the lowest allowable density on land guided for development from 2020-2030 and any reguided land from within the 2020 MUSA as changed from the city's 1998 CPU.
- c) The Council will not figure into the density calculation remaining undeveloped land within the 2020 MUSA per the city's existing 2020 plan, with the exception of areas that are being reguided in the 2030 CPU.
- d) If an area is replatted, the Council will not recalculate the density for this area in the plat monitoring program.
- e) Existing developments that are part of townships or areas being annexed from townships, or areas that were developed prior to 1985 with failing septic systems and no on site alternative septic locations will not be counted against a city's density calculation.
- 2. amend the Guidelines for Evaluating Plan Amendments Proposing Changes to Metropolitan Urban Service Area(MUSA) Timing-Staging per the guidelines as included in #1."

## 2007-238 - City of Jordan 2020 Comprehensive Plan Update, Review File 19840-1

# <u>2007-250</u> - Change in Scope of Grant SG-06106 to include Funding for Trail Project in Como Regional Park and Request for Reimbursement Consideration in Future Regional Parks CIP for Portion of Trail Project Funding, City of St. Paul

It was moved by Wolter and seconded by Sanda

"That the Metropolitan Council:

- approve the request to consider reimbursing the City of St. Paul up to \$148,797.19 in the 2008-09 regional parks capital improvement program for partially financing the redevelopment of trails and new trail construction in Como Regional Park as described in Attachment 1. However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement;
- 2. authorize a change in scope of Grant SG-2006-106 that allows up to \$147,202.81 to be spent for the Como Regional Park trail project referenced in recommendation 1 and \$65,797.19 to be spent for a reimbursement on the East Lakeshore Drive rehabilitation project in Como Regional Park."

Responding to questions, Bill Moore, ES General Manager, stated that wastewater facilities relocation cost sharing is policy driven by MnDOT and federal reimbursement guidelines. When MCES has an easement, MnDOT will relocate at their cost, with MCES responsible for any enhancements. When MCES is in MnDOT right-of-way by permit, MCES must pay for cost of relocation. MCES strategy for the future is to acquire easements as much as possible to minimize MCES costs for future relocations.

  - The provisions of the Americans with Disabilities Act (Pub. L. 101-336, 104 Stat. 327, as amended) and U.S. DOT regulations (Transportation for Individuals with Disabilities (40 CFR parts 27, 37 and 38).
- 3. certify the TIP conforms with the provisions of 49 CFR part 20 regarding lobbying restrictions on influencing certain federal activities;
- 4. find that the TIP is consistent with the Transportation Development Guide Chapter/Policy Plan, which is in conformance with applicable federal transportation and air quality regulations;
- 5. find that the TIP meets all applicable federal requirements;
- 6. find that the TAB provided adequate opportunity for public, agency and transit operators involvement through its regular process and special public meetings, and

hearing;

7. transmit the 2007-2010 TIP along with these comments to the Minnesota Department of Transportation and Minnesota Pollution Control Agency."

### Urban Partnership Agreement (UPA) Overview

Arlene McCarthy, Director of Metropolitan Transportation Services, presented a summary of the Urban Partnership Agreement, a new USDOT program.. The Twin Cities will receive a \$133 million federal grant to improve transit and ease congestion in four areas: tolling/congestion pricing, transit enhancements, technology and telecommuting. Legislative authority for a 20% local match and enabling legislation is required within 90 days of the next session opening.

Joint Met Council/MnDOT steering and technical committees will be established to discuss project planning and implementation. Chair Bell noted 35W will always be a congested corridor and the message from the steering committee should reflect that congestion will be reduced, but not eliminated.

# State Fair Ridership

Brian Lamb, General Manager of Metro Transit, reported record breaking ridership numbers for the 2007 State Fair Service and the month of August. Metro Transit, MVTA and SouthWest Transit surpassed one million rides. The result of the State Fair Service success meant no public dollars were spent this year.

- 4. he, Regional Administrator Weaver and Council staff met with Jon Gurban, Minneapolis Parks and Recreation Board (MPRB), and reached agreement on "Additional Acreage" parcels on Nicollet Island. The agreement is subject to MPRB approval. Maps will be sent to Council Members.
- 5. ongoing discussion with Governor's staff on 2008 transportation funding;
- 6. he and Council staff met with University of Minnesota officials on the Energy Research Collaboration;
- 7. that cities are expected to submit Comp Plans by the December 31, 2008 deadline. Guy Peterson noted Community Development staff have communicated often to communities that they are expected to comply with the legal requirement.

### Council Members

Council Member Smith reported an increase in University of Minnesota UPASS subscribers.

## Regional Administrator

Beth Widstrom Anderson sat in for Regional Administrator Weaver. There was no report.

### General Counsel

Mr. Grossman reported there are five new lawsuits.
