Proposed Action/Motion

That the Metropolitan Council authorize the Regional Administrator to prepare and publish a Notice of Intent, for publication in the *Federal Register* and a Notice of Preparation, for publication in the State EQB *Monitor* notifying interested agencies and the general public of the Metropolitan Council's intent to prepare a Supplemental Draft Environmental Impact Statement (SDEIS) as part of the Central Corridor Light Rail Transit (LRT) project development process.

Issue(s)

The FTA has indicated that, in order to document and disclose unresolved issues contained in the DEIS published in April 2006, an SDEIS should be prepared at this time.

The SDEIS will be limited in scope and will focus on changes and new information from the DEIS. For each of the changes from the DEIS, the SDEIS will describe the change and the reasons for the change and compare the impacts to those of the original proposal.

Key elements to be addressed in the SDEIS will include, at a minimum, the following issues:

- 1. Hiawatha / Central Connection
- 2. University of Minnesota alignment (tunnel vs. at-grade and stations)
- 3. Potential Added Station at: Western, Victoria or Hamline
- 4. Capitol Area Alignment/Station Modifications
- 5. Downtown St. Paul Alignment/Station Modifications
- 6. Right-of-Way for Systems Components traction power substations
- 7. Design for 2- or 3-Car Trains / Platforms
- 8. Maintenance and Storage Facility Needs

FTA will provide final direction regarding the key issues for analysis in the SDEIS no later than December 5, 2007. Any adjustment will be presented to Metropolitan Council on December 12, 2007, following which publication of a federal Notice of Intent and a State Notice of Preparation would take place.

Overview and Funding
