Proposed Action

That the Council concur with the Transportation Advisory Board (TAB) action to amend the 2008-2011 TIP indicate that Ramsey County is the lead agency for the project and that the total project cost is increased to \$15,250,000.

Background

Century Avenue is the county line between Washington and Ramsey County. The lead agency has changed from Washington County to Ramsey County. The scope of the project was changed in 2005 to lengthen the project by 0.4 miles. The project cost total has increased over 35% due to the increased length of the project, the unexpected drainage costs, increased retaining wall costs, additional right-of-way costs, drainage expenses and project inflation costs. The additional costs will be paid by the Counties (additional background material is attached).

Rationale

In order to spend federal transportation funds, the project must be included and accurately described in the current TIP.

Funding

The project cost has increased but will be paid for by the Counties.

Known Support / Opposition

The amendment was submitted by MnDOT on behalf of the two counties. There is no known opposition to the amendment.

PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

This amendment is needed to update the total cost of the project and revise the SP to indicate the change in lead agency from Washington County to Ramsey County.

In August 2005, a scope change was submitted to the TAB and was approved to lengthen the project from Valley Creek Road to Lake Rd., a distance of 0.4 miles. The project total has increased over 35% due to a variety of reasons. The increase in the length of the project, the unexpected drainage costs identified through project discovery, and project inflation costs are some of the factors attributed to the cost increase. Also, retaining wall costs increased to avoid 4f properties, additional R/W costs and accommodate drainage needs. The additional costs will be paid by the County.

Century Ave. is the County line between Washington and Ramsey County. Originally Washington County was identified as the lead agency for the project but this has changed to Ramsey County. The project number has been changed to reflect a Ramsey County project.
