Subject: Authorization to Award and Execute a Contract for Solid Waste Disposal Services at the Metropolitan Wastewater Treatment Plant

Proposed Action:

That the Metropolitan Council authorize the Regional Administrator to award and execute a Contract with Veolia ES – Vasko Rubbish Removal in the amount of \$649,386.98 to provide solid waste disposal services at the Metropolitan Wastewater Treatment Plant for a period of three years with an option to extend for two additional one-year periods.

Summary of Committee Discussion / Questions:

The Committee asked how the amount of the current contract compares to the new one, and how much of it has been used. Staff responded that the current contract amount was \$600,000 and, to date, nearly \$500,000 has been paid. When all invoices have been received, they will come close to the total contract amount. Motion to accept proposed action was made, seconded, and passed unanimously.

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute a Contract with Veolia ES – Vasko Rubbish Removal in the amount of \$649,386.98 to provide solid waste disposal services at the Metropolitan Wastewater Treatment Plant for a period of three years with an option to extend for two additional one-year periods.

Background

The Metro Wastewater Treatment Plant requires solid waste disposal services for trash, screenings and grit on a continuous basis. The current contract for these services will end in April 2008.

Rationale

- A formal Invitation for Bids for these services was issued February 11, 2008 allowing bidders to submit unit price bids for each type of service. Bid packages were sent to 14 interested vendors.
- Four bids were received on March 4, 2008. Bid amounts ranged from \$649,386.98 to \$988,088.00. The incumbent contractor, Veolia ES – Vasko Rubbish Removal was the lowest responsive, responsible bidder.
- The contract will be for a period of three years, with an option to extend for two additional 2 one-year periods at the same rates, terms and conditions.

Funding

Funds are available in the annual operating budget of the Metropolitan Wastewater Treatment plant.
