# **Proposed Action**

That the Metropolitan Council adopt the attached resolutions and authorize the Regional Administrator to enter into a state-aid agreement with MnDOT Aeronautics for purposes of fund disbursement if a grant offer is received and accepted.

# Background

The Council periodically applies to the Federal Aviation Administration (FAA) for Planning Grant funding to be used in updating the regional aviation system plan for the Minneapolis-St. Paul region. Results of the system plan evaluation are incorporated into the Transportation Policy Plan (TPP).

# Rationale

There have been considerable social, economic, and operational changes in air transportation over the past few years and updating the aviation element of the TPP is timely. A technical update at this time will also allow the Council to take advantage of current updates to individual airport and community plans.

# Funding

The funding request is for \$250,000 with a 95% federal contribution and 5% local share; the local share is an in-kind match. Grant funding will be used for consultant technical assistance with the system analysis and update. If a grant offer is received and accepted the Council budget will be amended to include the new revenue and expenditure. A state-aid agreement will also be executed with MnDOT Office of Aeronautics for purposes of fund disbursement.

# **RESOLUTION NO. 08-06**

#### RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE DEPARTMENT OF TRANSPORTATION, UNITED STATES OF AMERICA, FOR A GRANT UNDER THE AIRPORT IMPROVEMENT PROGRAM OF 1982

WHEREAS, the Secretary of Transportation is authorized to make grants for aviation planning projects; and

**WHEREAS**, the contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of project costs; and

**WHEREAS,** it is required by the U.S. Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Airport Improvement Program, the applicant give an assurance that it will comply with the Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder;

#### NOW THEREFORE BE IT RESOLVED:

- 1. THAT the Regional Administrator is authorized to file and execute an application on behalf of the Metropolitan Council, to aid in the financing of an Aviation System Planning grant;
- 2. THAT the Regional Administrator is authorized to execute and file with such applications an assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964;
- 3. THAT the Regional Administrator is authorized to furnish such additional information as the U.S. Department of Transportation may require in connection with applications or projects;
- 4. THAT the Regional Administrator is hereby authorized to execute the grant contract offered by the Federal Aviation Administration.
