Proposed Action

That the Metropolitan Council approve the following appointments to the Transportation Advisory Board (TAB): Precinct A—STEVEN SCHULTE; Precinct B—WILLIAM GUIDERA; Precinct C—JAMES MEYERS; Precinct D—CHUCK HAIK; Transit—RICHARD MUSSELL and GLENN OLSON; Non-Motorized Transportation—DAVID GEPNER.

Background

Terms of the following positions on the Transportation Advisory Board (TAB) expired Jan. 2008 and need to be filled: TAB precincts A, B, C, D (Metropolitan Council districts 1-8), two positions representing transit and one representing non-motorized transportation.

Rationale

- The TAB was established by the Metropolitan Council pursuant to MN Statutes 473.146, Subd. 4. The TAB's purpose is to advise and assist the Council, the Minnesota Dept. of Transportation (MnDOT), and all political subdivisions in accomplishing the responsibilities designated by state and federal law and regulation with regard to transportation planning and programming for the Twin Cities metropolitan area.
- The TAB is a 33-member body composed of elected officials, representatives of government agencies involved in transportation issues, citizen members, and members who represent public transit, the freight industry and non-motorized transportation. The Metropolitan Council appoints 12 members—8 citizen members, 2 members representing public transit, 1 member representing non-motorized transportation, and one member of the Metropolitan Council. In addition, the Council is responsible for appointing the TAB chair from among the advisory body membership.
- TAB members serve staggered two-year terms. Terms for all seven positions expired January 2008.
- A news release seeking applications for appointment was published in January 2008.
- Because two members—Steven Schulte (Precinct A) and Richard Mussell (Transit), were recently appointed (late 2007) to complete terms of positions that became vacant due to resignations, the decision was made to reappoint them at this time. Therefore, the news release solicited applications for Precincts B, C, D, one transit representative and the non-motorized transportation representative. Eighteen (18) applications were received for these positions. Council members were provided with copies of the applications and asked for their appointment recommendations. Comments received were forwarded to Chair Bell for consideration.
- Appointment recommendations for all seven positions are being forwarded for Council approval at this time.

Proposed Action/Motion:

That the Metropolitan Council approve the appointment of Council Member Dan Wolter, effective immediately, as a member to the Audit Committee for an unspecified term.

Issue(s)

There is vacancy on the Audit Committee due to resignation.

The Council Chair and members have strived to establish a committee membership that is a blend of current members and individuals who have not yet had an opportunity to serve.

Overview and Funding

Bylaws of the Audit Committee, (passed by Council, September 10, 2003, 2003-233) call for 6 voting members. Three shall be Council members and three shall be external members with expertise in such areas as finance, accounting, auditing, information systems, management, operations or program performance.

The bylaws also provide that, when a vacancy occurs, the Audit Committee members shall be appointed by the Council Chair and approved by the full Council.

Council Member Dan Wolter is director of the University News Service at the University of Minnesota. He served previously as communications director for Governor Pawlenty and special assistant to the Governor's Health Cabinet. He is also the former director of speechwriting for the United States Department of Agriculture; director of public affairs for the Minnesota House of Representatives office of the Speaker and Majority Leader; a senior account executive for Weber Shandwick Worldwide; and deputy communications director to Iowa Governor Terry Branstad. He earned his bachelor of arts degree cum laude from Drake University in Des Moines, Iowa in 1993. Council Member Wolter currently serves on the Transportation and Environment Committees of the Council.

Recommendation

Audit Committee Chair Lynette Wittsack and Chair Peter Bell recommend Council Member Wolter's appointment.
