Proposed Action

That the Metropolitan Council authorize the Regional Administrator to purchase light rail vehicle parts in accordance with Council specifications from Vulcanite Australia in the amount of \$799,512, contingent on the Federal Transit Administration granting a waiver of the Buy America waiver provision.

Background

Metro Transit is scheduled to overhaul its 27 light rail vehicles (LRVs) over a two-year period beginning July 2009 and continuing through July 2011. The LRVs will reach approximately 500,000 miles each during the two-year period, at which time the vehicle manufacturer recommends overhaul of the vehicle.

The parts required to overhaul the LRVs are estimated to cost \$5.1 million. The parts with long-lead times were ordered in 2007. The rest of the required parts are now being procured.

The Council issued an Invitation for Bids for various LRV suspension parts related to the gearbox and truck frame. The solicitation was advertised in the State Register, on the Council's website, and directly sent to seven manufacturers. Two bids were received. The low bid of \$799,512 was submitted by Vulcanite Australia. This low bid price is less than the cost estimate for this purchase.

Rationale

These parts are required for overhaul of the Metro Transit's 27 LRVs.

Funding

This purchase will be assisted with FTA funds and is contained in Project 61750 Overhaul LRT Vehicles.
