Background

Business Item 2008-154, which amends the Authorized Capital Program, added new funding for several projects of immediate need. NCDA funds a coach lease for their Northstar commuter bus service using funds earned through their participation in the National Transit Database reporting program. The additional funds of \$68,190 here represent their 2008 earnings.

SouthWest Transit and Minnesota Valley Transit Authority have annual debt related principal payments to make relating to the previous construction of a station and garage. These agreements will represent their 2008 principle payments on the debt.

Funding

The funding for these agreement is concurrently being amended into the 2008 Authorized Capital Program with the Business Item 2008-154.

Known Support / Opposition

SouthWest Transit, MVTA, and NCDA are aware of and support the Metropolitan Council's intention to execute these grants.
