Subject: Authorization to Negotiate and Execute an Agreement with the City of Princeton to Trade Phosphorus Credits

Proposed Action:

That the Metropolitan Council authorizes its Regional Administrator to negotiate and execute an agreement with the City of Princeton to trade phosphorus credits.

Summary of Committee Discussion / Questions:

The City is planning to build a new wastewater treatment plant to replace its pond system, resulting in a discharge to the Rum River for the first time. The Committee asked about the accuracy of determining the amount of phosphorus discharged by the new plant. Methods to measure pollutants in wastewater are well established. Since wastewater flows and phosphorus concentrations will be regularly measured at both the City and Council treatment plants, the specific phosphorus loads discharged from the plants will be well known.

Committee members inquired about the nonpoint source projects. The trading agreement will include a list of non-point source projects that the City can implement, with specific phosphorus reduction estimates included. The phosphorus reduction estimates are based on the implementation of accepted best management practices, rather than on direct measurement of the reduction of phosphorus in runoff from the nonpoint source sites. In addition, the agreement will include provisions to address failure to perform by the City. The City will report on its progress by submitting annual reports to the Council.

Motion to accept proposed action was made, seconded, and passed unanimously.

Proposed Action

That the Metropolitan Council authorizes its Regional Administrator to negotiate and execute an agreement with the City of Princeton to trade phosphorus credits.

Background

At the August 14 and December 11, 2007 meetings of the Environment Committee, staff presented the concept of trading water quality credits. In addition, the Minnesota Pollution Control Agency (MPCA) recently approved a policy to allow a wastewater treatment plant within the Lake Pepin watershed to sell its excess capacity of phosphorus load to another wastewater treatment plant that needs to grow. The City of Princeton and Council staff have been in discussions regarding trading and are finalizing a trading agreement. Highlights of the agreement are as follows:

- MPCA will reduce the phosphorus cap at the Metro Plant by 6,000 pounds (a 1.2 to 1 trade ratio)
- MPCA will authorize Princeton to discharge 5,000 pounds of phosphorus
- Princeton agrees to reduce nonpoint sources of phosphorus by 10,000 pounds (a 2 to 1 trade ratio)
- The 6,000 pounds of traded phosphorus load returns to the Metro Plant when the agreement ends

Rationale

Trading phosphorus load with the City of Princeton will allow them to proceed to build a new plant that can accommodate growth and development in the area. By requiring reductions in nonpoint sources of phosphorus in lieu of a cash payment, phosphorus reduction will actually be achieved, not only locally, but in the metropolitan area and further downstream. Nonpoint source phosphorus reduction is in the long term interest of the Council.

Funding

Known Support / Opposition

The City of Princeton seeks the water quality credit trade and the Minnesota Pollution Control Agency has adopted a policy endorsing of water quality credit trading.
