#### **Proposed Action**

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2008-2011 Transportation Improvement Program (TIP) to add a Transportation Revolving Loan Fund (TRLF) project for elevated pedestrian walkway from Ramp A to the Twins Ballpark over 7<sup>th</sup> St. N in Minneapolis.

## **Background**

This amendment is needed to identify \$3,375,000 in TRLF funding to construct a new elevated pedestrian walkway to serve additional pedestrian flow that is anticipated with the opening of the new Twins Ballpark. The walkway will directly connect Ramp A to the Twins Ballpark by crossing over 7<sup>th</sup> St. North at 3<sup>rd</sup> Ave. North.

#### Rationale

In order to use the TRLF Funds the project must be in the current TIP.

#### **Funding**

These are new funds so the fiscal balance of the TIP is maintained.

#### PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

This amendment is needed to add a new project to the 2008-2011 STIP in SFY 2009.

In 1992, the FHWA, MnDOT and City of Minneapolis completed the I-394 facility. This was the first interstate project in the United States to include high occupancy vehicle lanes, transit facilities, parking ramps and skyways. This integrated approach was selected to mitigate the potential environmental effects of traffic. The purpose of the ramps was to provide an incentive to commuters who carpool or ride the bus on I394 into downtown Minneapolis.

A new elevated public walkway will be constructed to serve additional pedestrian flow that is anticipated with the opening of the new Twins Ballpark. The walkway will directly connect Ramp A to the Twins Ballpark by crossing over 7<sup>th</sup> St. N. at approximately 3<sup>rd</sup> Ave. N. Accommodating a large percentage of crossing pedestrians at the second level would greatly reduce pedestrian-vehicle conflicts along the street level. Travel time should be significantly reduced for vehicles traveling on 7<sup>th</sup> Street North due to greatly reduced pedestrian interaction. Pedestrians will also have a safe, direct link to and from the ballpark which connects to the downtown skyway system and should result in safety benefits at many intersections throughout downtown by reducing pedestrian interactions with vehicles.
