Issue(s)

As part of the process for approving the Council's 2009 Unified Operating Budget, 2009-2014 Capital Improvement Plan and 2009 Capital Program and Budget, the Council may hold a public hearing.

Overview

The Council is not required to hold a Truth in Taxation hearing this year, but to ensure the public has an opportunity to provide input on the 2009 budgets, a public hearing is recommended.

In 2007, the Council authorized the Management Committee to set the public hearing date for the Unified Operating Budget, Capital Improvement Program, Capital Program and Capital Budget.

MS Sec. 473.13, Subd. 1, the Council is required to, on or before December 20, adopt a final budget covering its anticipated receipts and disbursements for the ensuing year and decide upon the total amount necessary to be raised from ad valorem tax levies to meet its budget.

MS Sec. 473.535 requires the Council to prepare and adopt a capital improvement program and a budget.

The Council is currently scheduled to adopt the budgets at the Council Meeting on December 10th, 2008.
