Subject: City of Lake Elmo Comprehensive Plan Update Extension Request

Proposed Action

That the Metropolitan Council extend the City's "decennial" comprehensive plan update (Update) submission deadline to May 29, 2009, subject to the following terms and conditions:

- 1. If the City submits the Update to the Council by May 29, 2009 that is "complete" for review as defined in the Council's Local Planning Handbook and the adjacent review requirements have been completed by May 29, 2009, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 2. If the adjacent review requirements have not been completed by May 29, 2009, but the City submits the Update to the Council by May 29, 2009 that otherwise is "complete" as defined in the Council's Local Planning Handbook, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 3. If the City has not submitted the Update by May 29, 2009 that is "complete" as defined in the Council's Local Planning Handbook, the City must repay by July 30, 2009 all grant funds paid to the City under the grant agreement.
- 4. The grant agreement should be amended to: (a) extend the December 31, 2008 plan update submission deadline to May, 29, 2009; (b) reflect these terms and conditions; (c) make the execution of the grant amendment expressly conditioned on the City's acceptance of these terms and conditions; and (d) require a written bi-monthly progress report that describes in reasonable detail the City's progress toward meeting the May 29, 2009 deadline; and (e) in order to accommodate the statutory 6-month adjacent and special jurisdiction review period, the community must submit its final Update no later than December 31, 2009, and notify the Council of any changes made to the Update from the May 29, 2009 submission.

Summary of Committee Discussion / Questions

Council staff presented an overview of the requests received from communities for extension of the deadline for submitting comprehensive plan updates. The Committee focused on two distinct groups of cities making requests; 1) those without local planning assistance grants from the Council; and 2) the three that have been given local planning assistance grants. All three cities requested extensions of one full year or more.

The Committee questioned why Lake Elmo's Update would take so long to complete. Mayor Dean Johnston of Lake Elmo spoke on behalf of the City to explain their situation and proposed timeline.

Committee member Bowles moved to add a provision to the proposed actions a final date by which communities must submit their Updates to accommodate the required statutory 6-month review period and to respond to any comments received during that period.

The Committee agreed (5-2 vote) to extend the Update submission deadline to May 29, 2009, for these cities subject to the terms and conditions detailed under Proposed Actions above, including provision 4(e) as moved by Committee member Bowles.

Proposed Action

That the Metropolitan Council extend the City's "decennial" comprehensive plan update (Update) submission deadline to May 29, 2009, subject to the following terms and conditions:

- 1. If the City submits the Update to the Council by May 29, 2009 that is "complete" for review as defined in the Council's *Local Planning Handbook* and the adjacent review requirements have been completed by May 29, 2009, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 2. If the adjacent review requirements have not been completed by May 29, 2009, but the City submits the Update to the Council by May 29, 2009 that otherwise is "complete" as defined in the Council's *Local Planning Handbook*, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 3. If the City has not submitted the Update by May 29, 2009 that is "complete" as defined in the Council's *Local Planning Handbook*, the City must repay by July 30, 2009 all grant funds paid to the City under the grant agreement.
- 4. The grant agreement should be amended to: (a) extend the December 31, 2008 plan update submission deadline to May, 29, 2009; (b) reflect these terms and conditions; (c) make the execution of the grant amendment expressly conditioned on the City's acceptance of these terms and conditions; and (d) require a written bi-monthly progress report that describes in reasonable detail the City's progress toward meeting the May 29, 2009 deadline.

Background

In the request materials, the City of Lake Elmo explains that approval of the current comprehensive plan, implementation of the first phase of sewered development, the Village Alternative Urban Area-wide Review (AUAR) to assess development capabilities in the downtown part of the City, preparation of a water plan, staff turnover, budget constraints, and ample public participation have delayed the completion of the Update. The City indicates that the draft of the Update will be complete by March 2010, with the adjacent community and affected jurisdiction review being initiated in April 2010. The 6-month review period would then be complete in November, with submission of the Update to the Council by December 2010.

<u>May 2007 Council Action.</u> In May 2007, the Council authorized staff to implement a local planning assistance grant program to help ensure qualifying local governments and counties could prepare and submit their "decennial" Updates to the Council by the statutory December 31, 2008 deadline.

<u>Grant Agreement.</u> The City was awarded a \$20,000 Local Planning Assistance Program grant in 2007. The grant agreement requires the City to:

- 1. review and update its comprehensive plan by December 31, 2008;
- 2. submit its draft plan update to adjacent governmental units by June 30, 2008;
- 3. discuss its draft plan with watershed management organizations;

- 4. submit a "complete" plan as described in the Council's Local Planning Handbook; and
- 5. ensure its plan conforms with the Council's metropolitan system plans.

The grant agreement further provides that if the City does not comply with the terms and conditions of the agreement, "the Council may take any action to protect its interests and may require the [City] to return all or part of the [grant] funds."

<u>December 31, 2008 Deadline.</u> Minnesota Statutes section 473.864 requires local governmental units to review and, if necessary, amend their entire comprehensive plans on a decennial basis. The current "decennial" review deadline is December 31, 2008. Section 473.864 authorizes the Council to grant extensions to local governmental units to allow those units additional time to review and, if necessary, amend their comprehensive plans. The extensions must include a timetable and plan for completing the plan review and amendment.

June 2008 Council Action. On June 25, 2008, the Council adopted guidelines for granting requests to extend the "decennial" plan update submission deadline. Subject to certain conditions, the guidelines authorized staff to "administratively" grant extensions to May 29, 2009. If plan updates and adjacent reviews could not be completed by May 29, 2009, the guidelines state that extension requests require action by the Council's governing body.


Rationale

The City's request for an extension to December 2010 is two years beyond the statutory submittal deadline and a year and a half beyond the extended administrative date. The City has provided a significant amount of information in their extension request, detailing the work that remains to be completed and the timelines for completing those items. A summary of the timeline to complete the remaining elements is provided in the table below with additional detail provided in the attached documents.

To coordinate regional system planning and to ensure conformity to regional system plans and compatibility with the plans of adjacent and overlapping jurisdictions, it is reasonable to expect communities to submit their comprehensive plans by the December 31, 2008 deadline, or within one year thereafter. System Statements were sent to communities in September 2005, giving communities a little over three years to begin and complete the comprehensive planning process. Allowing four years total should be more than enough time to complete the requirements for the Update.

Two other communities have submitted deadline requests similar to that of Lake Elmo. To ensure consistency with and conformity to the 2030 Regional Development Framework and accompanying system plans, local comprehensive plan updates should be submitted and reviewed within a short timeframe, rather than being allowed to be submitted over several years.

The City has completed a number of major tasks, including the Village Master Plan, the Village Sewer Study, educational workshops on building and financing infrastructure, a financing study for the sewer wastewater system, and authorization to prepare plans and specifications for the sewer interceptor from I-94 to 30th Street. In addition, the City has also completed a Comprehensive Parks and Recreation Plan. Recently discovered groundwater contamination issues resulting from previously produced and disposed 3M chemicals have lengthened the water supply planning process, but is anticipated to be completed by March 2009.

Due to the degree of change being considered for the Village in the AUAR process, the City cannot begin the Transportation Plan until a development scenario for the Village is selected. However, this element, along with other remaining elements of the Update could be accelerated and completed in 2009, rather than being carried over into 2010. Since the Surface Water Plan and the Transportation Plan have not yet been initiated, the City has the ability to indicate in their hiring contracts the specific timeline required to complete these plans.

Staff recommends that the Metropolitan Council extend the City's "decennial" Update submission deadline to May 29, 2009 subject to the following terms and conditions:

- 1. If the City submits the Update to the Council by May 29, 2009 that is "complete" for review as defined in the Council's *Local Planning Handbook* and the adjacent review requirements have been completed by May 29, 2009, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 2. If the adjacent review requirements have not been completed by May 29, 2009, but the City submits the Update to the Council by May 29, 2009 that otherwise is "complete" as defined in the Council's *Local Planning Handbook*, the City will be eligible to receive the second disbursement of grant funds described in the grant agreement.
- 3. If the City has not submitted the Update by May 29, 2009 that is "complete" as defined in the Council's *Local Planning Handbook*, the City must repay by July 30, 2009 all grant funds paid to the City under the grant agreement.
- 4. The grant agreement should be amended to: (a) extend the December 31, 2008 Update submission deadline to May, 29, 2009; (b) reflect these terms and conditions; (c) make the execution of the grant amendment expressly conditioned on the City's acceptance of these terms and conditions; and (d) require a written bi-monthly progress report that describes in reasonable detail the City's progress toward meeting the May 29, 2009 deadline.

Funding

Lake Elmo was one of 49 communities to receive a local planning grant from the Council. Half of the \$20,000 grant money has already been awarded, pursuant to the terms of the grant. The remaining \$10,000 is due to be awarded upon completion of the Update, with the condition that the Update be submitted by December 31, 2008 as indicated in Section 2.01 of the planning grant agreement. The grant agreement allows for amendment of the agreement, including amending the Update submission date. It is reasonable to agree to amending the planning grant agreement submission deadline to May 29, 2009.

CITY OF LAKE ELMO RESOLUTION NO. 2008-45

RESOLUTION REQUESTING ADDITIONAL TIME WITHIN WHICH TO COMPLETE COMPREHENSIVE PLAN "DECENNIAL" REVIEW OBLIGATIONS

WHEREAS, Minnesota Statutes section 473.864 requires local governmental units to review and, if necessary, amend their entire comprehensive plans and their fiscal devices and official controls at least once every ten years to ensure comprehensive plans conform with metropolitan system plans and ensure fiscal devices and official controls do not conflict with comprehensive plans or permit activities that conflict with metropolitan system plans; and

WHEREAS, Minnesota Statutes sections 473.858 and 473.864 require local governmental units to complete their "decennial" reviews by December 31, 2008; and

WHEREAS, Minnesota Statutes section 473.864 authorizes the Metropolitan Council to grant extensions to local governmental units to allow local governmental units additional time within which to complete the "decennial" review and amendments; and

WHEREAS, any extensions granted by the Metropolitan Council must include a timetable and plan for completing the review and amendment; and

WHEREAS, the City will not be able to complete its "decennial" review by December 31, 2008, for the following reasons:

- One of the primary reasons for the delay in these elements was the time and thought that went into creating the current 2030 comprehensive plan and getting Metropolitan Council approva of it. This plan encompasses most of the required information for this update, as well as the work that is going into implementing the first phase of sewered development. In addition, the city, under the leadership of the planning commission, brought the two areas in the city planned for future sewered growth into conformance with the zoning code through holding districts.
- 2) The comprehensive required the city to proceed with sewered development with the Village as the highest priority for this work according to both the MOU requirements and the 2030 Comprehensive Plan. This effort requires land use planning, environmental, financial and engineering studies to gather information that will allow the city to make the associated decisions to accomplish these required goals. This work has been a priority since the adoption of the 2030 plan in 2006
- 3) A major environmental review process (AUAR) involving the Village is underway at this time. The outcome of this analysis will provide important information related to water, surface water and transportation needs for the city to incorporate into its future plan elements.
- 4) The city undertook a water plan in 2005, but put the plan on hold until the outcome of the PFC contamination work on health based values that was done by the Minnesota Department of Health and released in the spring of 2008. The city is now working on the water plan.
- The city was functioning without a planning director from December, 2006 through December, 2007. Once hired, the new planning director requires getting acquainted with the community and land use actions and history;
- 6) It was important to determine the true status of the city's financial resources before proceeding with major studies in surface water and transportation without confidence that the city had the resources to pay for this work since fund balances at year end were in the negative for these

funds. Between January 2008 and June 2008 upon the advice of the city auditor, the city worked with a financial consultant to bring the city's financial records into conformance with best practices in local government.

7) The city is committed to an open public process including opportunities for public input throughout these studies. This requires coordinating the activities so that there is time for input on all of the systems in a meaningful way.

WHEREAS, the City Council finds it is appropriate to request from the Metropolitan Council an extension so the City can have additional time to complete and submit to the Metropolitan Council for review an updated comprehensive plan and amend its fiscal devices and official controls.

NOW, THERFORE, BE IT RESOLVED BY THE CITY COUNCIL OF LAKE ELMO, MINNESOTA, AS FOLLOWS:

1. The Planning Director is directed to submit to the Metropolitan Council no later than November 1, 2008, an application requesting an extension to December 2010.

The Planning Director must include with the request a reasonably detailed timetable and plan for completing: (a) the review and amendment by December 2010 and (b) the review and amendment of the City's fiscal devices and official controls.



BACKGROUND

The city of Lake Elmo finalized its current comprehensive plan in August, 2006. The priorities in the plan dealt with the future land use of two areas that are guided for sewered development. A January 2005 Memorandum of Understanding and the 2030 Lake Elmo Comprehensive Plan include specific expectations for sewered development in Lake Elmo. The city has diligently worked toward achieving these goals by beginning with making the future Village, which is guided for sewer, a development priority. This is a major project and is moving along at a measured, but consistent pace. This work has required substantial time on the part of the city council, staff and consultants. The attached timeline of activities associated with the Village project provides evidence that progress is being made.

Not only has the city's time been spent on the Village planning and related activities, it would be premature to do surface water and transportation planning without having the environmental information from the AUAR available for preparing these plans. This AUAR work is being finalized at this time so the information will be available for these studies. Following the AUAR on the Village development scenarios, the city will gather financial information on the possible scenarios and determine what development scenario is desirable for the future. This may require an amendment to the future land use section of the Village in the currefit (2030) comprehensive plan. The city has also used an extensive public process throughout the Village planning process and anticipates continuing to do so with the other planning elements.

LAND USE AND INFRASTRUCTURE PLANNING/FINANCING RELATED TO THE VILLAGE

FINANCIAL RECORD KEEPING

 In addition to these planning and infrastructure related activities, it became critical for the city to bring its financial records into conformance with government financing standards, which was accomplished during the first six months of 2008 and was completed in early June. This allows the city to know what financial resources are available for the planning studies related to the updating its comprehensive plan as well as be better prepared to develop the necessary capital improvement plans for the future infrastructure in the sewered areas as well as elsewhere in the

RELATED STUDIES

Minnesota Department of Health (MDH) PFC health based value study

The city began its water plan in 2005 but it was put on hold in 2006 when it was determined that it was critical to find the health based values for PFBA, a form of PFC contamination, before finalizing the plan. The PFBA health based value, one of three PFC values, was determined and announced in May, 2008. The city is currently proceeding with its water planning effort.

Transportation

Washington County is currently preparing its transportation plan which will provide useful in helping the city with its own transportation plan.

Washington County is leading on plans for an upgrade (probably interchange) for the intersection of Highway 36 and Lake Elmo Avenue (County 17). This planning process is underway now with a Design Review Committee with representatives from the cities of Lake Elmo and Grant. This is providing additional information for the city's future transportation plan. The Village AUAR has provided data for this study too.

Surface water

The three watersheds, Valley Branch, Browns Creek and Southwest Washington, have prepared surface water management plans that can be incorporated into the city's surface water management plan.
