#### **Proposed Action**

That the Metropolitan Council authorizes its Regional Administrator to negotiate and execute an engineering services agreement for general wastewater treatment plant engineering services with Howard R. Green for an amount not to exceed \$500,000.

#### **Background**

A Request for Proposal for engineering services was issued with three categories of services and associated examples of work. The stated intent was to award three engineering services contracts, covering three areas of expertise: 1) general wastewater treatment plant engineering; 2) specialized process engineering; and 3) electrical and HVAC engineering.

Fourteen proposals were received. The evaluation panel ranked each firm for each category under which they submitted a proposal and developed a short list of firms by category for further evaluation. These firms are:

1. General Engineering: Howard R. Green

Brown & Caldwell

2. Process Engineering: Brown & Caldwell

Black & Veatch

3. Electrical & HVAC: Sebesta Blomberg

**TKDA** 

Howard R. Green is recommended in the category of general engineering based on proposed local staff assignments and excellent previous MCES work experience.

#### Rationale

- Professional services contracts exceeding \$250,000 require Metropolitan Council authorization.
- It is prudent to have available contracted engineering services for wastewater treatment plant planning and design needs to ensure timeliness on small projects and to address needs that do not have a well-defined scope.

#### **Funding**

Funding is provided in the MCES Authorized Capital Program.
