Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action 2009-28 to amend the 2009-2012 Transportation Improvement Program (TIP) to include five projects (I-35E/CSAH 14 Interchange, Reconstruct White Bear Avenue, CSAH 21 Surfacing, TH7 & Wooddale Interchange and Travel Behavior Inventory) that may be funded using American Recovery and Reinvestment Act (ARRA) funds.

Background

These projects totaling \$56,885,000 will be funded with a combination of State and Regional ARRA funds in addition to other federal and local funds.

This action will allow these projects to be under construction by early summer. This action also positions Minnesota well to compete for potential ARRA funds redistributed from other states ARRA funds should they become available. The projects are consistent with the guiding principles developed by both MnDOT and the Transportation Advisory Board and are consistent with the Metropolitan Council 2030 Transportation Policy Plan.

Rationale

These projects are ready for letting.

Funding

The \$21,662,086 of ARRA funds includes \$6,670,000 of MnDOT ARRA funds and \$14,992,086 of TAB/Council Regional ARRA funds.

Known Support / Opposition

The TAB passed the amendment after significant discussion.

SUBJECT: Placement of STIP projects requesting regional ARRA funding into tiers and amend the 2009-2012 TIP amendment to include all Tier I and Tier II projects under Option 1.

MOTION: That the Transportation Advisory Board approves the placement of projects into the tiers or screening priorities in the table below and amends the 2009-2012 Transportation Improvement Program to include the five Tier I and Tier II projects within Option 1.

BACKGROUND AND PURPOSE OF ACTION:

Tiered Projects.

The Technical Advisory Committees and the TAB have discussed how to prioritize local projects and allocate the \$73.2 million in regional ARRA funds. The TAC and TAB agree that projects already in the STIP should be a higher priority for ARRA funding than project proposals that are not in the STIP. At a special TAC Funding and Programming Committee meeting on March 26, the committee met with the sponsors of the eight STIP projects listed above. The project sponsors responded to questions about their project. Based on their responses, the committee voted to place the eight projects in one of three tiers. See attached table for current cost estimates and funding amounts.

The projects are in different tiers depending upon the funding option chosen by the region. Under Option 1, MN/DOT will contribute state ARRA funds toward the Anoka County, St. Louis Park and Rogers interchange projects. MN/DOT would also be asked to contribute state ARRA funds toward the Metropolitan Council's Travel Behavior Inventory. Under Option 2, MN/DOT would not contribute state ARRA funds to any locally recommended project.

<u>Tier I:</u> The project scope is unchanged from the original project programmed in the STIP in 2010 or later. The project cost may have increased due to design modifications required by reviewing agencies or through the inflation in the cost of materials. MN/DOT has committed state ARRA funds to these projects under Option 1 and the project sponsor has committed to the local match amount in the STP-UG application submitted in the regional solicitation. The TAC recommended including the Metropolitan Council's Travel Behavior Inventory in Tier I.

<u>Tier II:</u> The project scope is changed compared to the description and cost in the STIP and would require a scope change approval. The project cost may have increased due to design modifications required by reviewing agencies or through the inflation in the cost of materials. MN/DOT has not committed state ARRA funds to these projects, but the project sponsor has committed a local match amount adequate to match the programmed STP-UG funds.

<u>Tier III:</u> The project scope is substantially different from the original scope programmed in the STIP, and/or the sponsor cannot provide the local match amount they committed to in their STP-UG application. MN/DOT has not committed state ARRA funds to these projects. All projects that are not currently in the STIP and are seeking 100% regional ARRA funding are included in Tier III.

The TAB will use these preference categories to help define funding options for use of the regional ARRA funding. In addition to the criteria above, the TAB will also consider geographic equity, diversity of project type and support of regional plans and the regional system. Applicants were encouraged to commit local funding to their projects so the region can stretch the ARRA funds farther. Selection criteria to consider projects in Tier III may also favor those projects that have as much local funding identified as possible.

2009-2012 TIP amendment.

The Technical Advisory Committee (TAC) discussed the tiered projects under the two option scenarios. The TAC concluded that the Tier I and Tier II projects would be chosen to receive ARRA funding under an Option 1 scenario where the I-494/TH169 interchange is not chosen to receive state and regional ARRA funds. The TAC voted to include the Metropolitan Council Travel Behavior Inventory as a Tier I project because of its value to the entire region and MN/DOT has expressed support for funding part of the cost with state ARRA funds. The TAC voted to recommend that the five Tier I and Tier II projects be amended into the TIP to expedite their implementation should the TAB vote to not fund the I-494/TH169 interchange project or if the FHWA does not allow the construction of a reduced scope design. Each project is listed separately in the attached information.

Please amend the 2009 – 2012 Transportation Improvement Program (TIP) to include five projects to be partially funded with State and Regional ARRA funds. These projects are being submitted with the following information (see attached tables).

PROJECT BACKGROUND:

The TAC recommends that five projects be funded partially with State and Regional ARRA funds under TAB Option 1. Should the TAB choose to help fund the TH169/I-494 Interchange, this amendment should not be adopted.

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

The amendment is needed to show the additional funds for four projects presently in the 2009-2012 TIP which were selected through the regional solicitation. The Travel Behavior Inventory is being recommended for partial ARRA funding due to its importance to the region. The TBI is not in the existing 2009-2012 TIP.
