Subject: Cooperative Construction and Utility Relocation Agreement and Loan Agreement with District Energy St. Paul and District Cooling St. Paul

Proposed Action

That the Metropolitan Council authorize the Regional Administrator:

- To negotiate and execute a Cooperative Construction and Utility Relocation Agreement with District Energy St. Paul and District Cooling St. Paul relative to the 4th Street Advance Utility Construction in Saint Paul in a principal amount not to exceed \$2,500,000; and
- To negotiate ~~and execute~~ a Loan Agreement acting as the Metro Housing and Redevelopment Authority (HRA) with District Energy and District Cooling requiring full reimbursement to the Council for the cost of installation. The execution of the agreement is subject to final review by the Council.

Summary of Committee Discussion / Questions:

Mark Fuhrmann gave an overview of utilities relocation on 4th Street in downtown St. Paul for the six blocks between Minnesota Street and Broadway Street. At the Transportation Committee, discussion provided for amendment to proposed action to include that the execution of this agreement shall be contingent on the Metropolitan Council completing the Final Environmental Impact Statement process and receiving a letter of No Prejudice (LONP) from FTA. After the Transportation Committee met and approved this item, the Management Committee approved the proposed action as amended above. The item passed unanimously.
