Hawkins Chemicals, Inc. in the amount of \$3,685,527 for the procurement of Chlorine (1-

Ton Cylinders), Sodium Hydroxide Solution (Caustic Soda), Sodium Hypochlorite (Bleach > 1,000 gallons), Aluminum Sulfate (Alum – totes), and Ferric Chloride;

<u>DPC Industries</u> in the amount of \$88,150 for Sodium Hypochlorite (Bleach < 1,000 gallons) and Liquid Sulfur Dioxide (1-Ton Cylinders);

<u>C&S Chemicals, Inc.</u> in the amount of \$1,251,070 for Aluminum Sulfate (Alum > 1,000 gallons); and

PVS Chemical Solutions, Inc. in the amount of \$650,370 for Sodium Bisulfite.

Proposed Action:

That the Metropolitan Council authorize the Regional Administrator to issue purchase orders to the following companies:

<u>Hawkins Chemicals, Inc</u>. in the amount of \$3,685,527 for the procurement of Chlorine (1-Ton Cylinders), Sodium Hydroxide Solution (Caustic Soda), Sodium Hypochlorite (Bleach > 1,000 gallons), Aluminum Sulfate (Alum – totes), and Ferric Chloride;

<u>DPC Industries</u> in the amount of \$88,150 for Sodium Hypochlorite (Bleach < 1,000 gallons) and Liquid Sulfur Dioxide (1-Ton Cylinders);

<u>C&S Chemicals, Inc.</u> in the amount of \$1,251,070 for Aluminum Sulfate (Alum > 1,000 gallons); and

PVS Chemical Solutions, Inc. in the amount of \$650,370 for Sodium Bisulfite.

Background:

Bids were solicited to supply several process chemicals for MCES facilities for a two year period. A formal Invitation for Bids was issued and responses were obtained from five potential suppliers of which four were successful. Responders were able to bid on one or all chemicals. The lowest responsive, responsible bidders were as follows:

Hawkins, Inc. was the lowest responsive, responsible bidder for Chlorine (1-Ton Cylinders), Sodium Hydroxide Solution (Caustic Soda), Sodium Hypochlorite (Bleach > 1,000 gallons), Aluminum Sulfate (Alum – totes), and Ferric Chloride.
