Subject: Northstar Commuter Rail Fares recommendation

Proposed Action: That the Metropolitan Council approves the recommended Northstar Commuter Rail Fares as set forth below.

Recommendation: This amended business item recommends an Introductory (temporary) and Permanent Commuter Rail Fares for Saturday, Sunday/Holiday Adult Fares (Table 1), and Saturday, Sunday/Holiday Senior, Youth, Medicare Social Fares (Table 2) and Fares for Persons with Disabilities (Table 3). An Introductory (temporary) Fare will be effective the first day of Northstar Commuter Rail Revenue Operations (up to a 12 month demonstration) in late 2009. The permanent fare will be effective 12 months after the first of Northstar Commuter Rail Revenue Operations. This permanent fare could be implemented earlier if approved by the Metropolitan Council.

The Introductory and Permanent Fare in Table 1 for Saturday, Sunday/Holiday service approximates the 25% discount fare for adult "non-peak" weekend express bus service as compared to the weekday peak rush rate. April 2009 Public Hearings stated the weekend fares would be within weekday fare rates. Bus issued Transfers will apply a \$1.00 value towards all Northstar Fares.

The Introductory and Permanent Fare in Table 2 for Senior, Youth and Medicare Social Fare customers approximates the up to 75% discount fare for "non-peak" weekend express bus service as compared to the weekday peak rush rate. These rates would

apply to weekend/holiday: Seniors (65+), Youth (6-12), and Medicare Card Holders. These discounted fares are in compliance with Federal Reduced Fare Guidelines. Children ages 5 and under ride free when accompanied by a paid fare.

Rationale

The recommended fare pricing reflects current travel market conditions for commuter's value of long distance and high quality service, while balancing ridership impacts and fare revenue generation. It programs pricing flexibility in a volatile economy, and time for the weekend market to be established over the next twelve months. Staff will routinely update the Council with Northstar ridership and revenue reports during the first twelve months of revenue service.

<u>Family/Group pass:</u> Over the next several months staff will develop a family or group discount program with a goal of implementation prior to April 2010 when the Minnesota Twins will begin their first season at the new Target Field ballpark. The objective is to make fares more affordable for those customers traveling as a family or group such as those who may ride Northstar Commuter Rail on weekends/holidays.

Summary of Committee Discussion / Questions: Adam Harrington presented the item which was amended based on Committee discussion on July 13. There were no questions from Council Members. Recommendation was approved unanimously.

Proposed Action/Motion

That the Metropolitan Council approves the recommended temporary and permanent Northstar Commuter Rail Fares for (1) Saturday and Sunday/Holiday Adult Fares; (2) Saturday and Sunday/Holiday Senior, Youth and Medicare Social Fares and (3) Fares for Persons with Disabilities as set forth below.

Background

After a detailed discussion at the July 13 Transportation Committee meeting, the Committee approved the weekday adult fares as recommended. These weekday adult fares are presented in Table 4 below.

The committee requested staff to return to a subsequent Transportation Committee with a new weekend fare that would reflect a similar "non-peak" rate discount to all customers as is applied to bus and light rail fares. The committee also requested clarification on Senior, Youth, Medicare and Persons with Disabilities Social fares. The fares developed for Senior, Youth, Medicare and persons with Disabilities were developed with similar discount percentages as the current bus system Peak and Offpeak fares.

Discussion at the June 24 Metropolitan Council meeting and July 13 Transportation Committee meeting include the desire to adjust Transit Fare Policy to match Federal Transit Administration (FTA) policy by removing the requirement to hold a public hearing when transit fares are adjusted lower. Transit Fare Policy 3-2-6, and 3-2-6a adjustments will be brought before the Transportation Committee and Metropolitan Council in a separate business item.

Recommendation

This amended business item recommends Introductory (temporary) and Permanent Commuter Rail Fares for Saturday, Sunday/Holiday Adult Fares (Table 1), and Saturday, Sunday/Holiday Senior, Youth, Medicare Social Fares (Table 2) and Fares for Persons with Disabilities (Table 3). An Introductory (temporary) Fare will be effective the first day of Northstar Commuter Rail Revenue Operations (up to a 12 month demonstration) in late 2009. The permanent fare will be effective 12 months after the first of Northstar Commuter Rail Revenue Operations. This permanent fare could be implemented earlier if approved by the Metropolitan Council.

The Introductory and Permanent Fare in Table 1 for Saturday, Sunday/Holiday service approximates the 25% discount fare for adult "non-peak" weekend express bus service as compared to the weekday peak rush rate. 

Funding

Setting fares is essential for managing the operating budget fare, software, media, administration procedures, promotion and future operational budget preparation. Fare revenue for the first year of operation is forecasted at 21% and for the second year of operations at 29%. (see table below).

Known Support / Opposition

The NCDA Board approved the \$3.25 flat rate for all stations on weekends/holidays.
