Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute subrecipient agreements with the specified agencies and for the specified amounts of federal Job Access and Reverse Commute (JARC) or New Freedom program funding identified in Attachment A.

Background

The projects receiving funding through the federal JARC and New Freedom programs were selected using a competitive solicitation process. A list of recommended projects was approved by the Council on February 11, 2009. These projects were also amended into the 2009 MTS Operating Budget on September 9, 2009.

Since some projects are continuing from their 2006-2007 JARC or New Freedom awards, additional funds will be added to their existing agreement. In this case, the amount in Attachment A represents the amended agreement value including any previous funding.

The subrecipients agree to provide the local match for these federal funds.

Rationale

The projects were selected using a competitive process and agreements must now be executed to allow for the disbursement of funding from JARC and New Freedom programs to the designated subrecipients.

Funding

Federal funding levels for existing agreements, new award amounts, and amended agreements are summarized in Attachment A. Subrecipients are responsible for providing the local match to their Federal funds as agreed to in their Subrecipient Agreement.

The amounts have been amended into the 2009 MTS operating budget as pass-through.
