Call to Order and Approval of Agenda

A quorum being present, the Chair called the regular meeting of the Metropolitan Council to order at 4:05 p.m. Chair Bell removed Items 2009-307 and 2009-308 from the Consent List, so they could be voted on separately. It was moved by Steffen, seconded by Broecker, to approve the amended agenda. Motion carried.

"That the Metropolitan Council authorize the Regional Administrator to amend the Metropolitan Council's contract with Iron Mountain for off-site records storage to increase the maximum compensation by \$56,780 to a total amount of \$284,170.

<u>2009-307</u> - Subordinate Funding Agreement #4 with the Minnesota Department of <u>Transportation for the Central Corridor Light Rail Project</u> It was moved by Hilker and seconded by Meeks

"That the Metropolitan Council authorize the Regional Administrator to negotiate and execute Subordinate Funding Agreement (SFA) #4 to the Master Funding Agreement with the Minnesota Department of Transportation (MN/DOT) in the not to exceed amount of \$25,000,000 for property acquisition for the Central Corridor Light Rail Project."

"That the Metropolitan Council authorize the Regional Administrator to negotiate and enter into a contract for the fully insured medical plan for the period of January 1, 2010, through December 31, 2012."

Council Member Sanda recused herself from the discussion and vote on this item.

2009-323 - Settlement of Litigation: MOAC Land Holdings, LLC v. Metropolitan Airport Commission and the Metropolitan Council

It was moved by Scherer and seconded by Wittsack

"That the Metropolitan Council authorize the Regional Administrator to settle the matter entitled *MOAC Land Holdings, LLC v. Metropolitan Airport Commission and the Metropolitan Council* on terms consistent with the discussion that occurred during the closed portion of the Management Committee meeting and to authorize the Regional Administrator and the Metropolitan Council's attorneys to take all actions necessary or appropriate to finalize a settlement of the above-entitled matter."

It was moved by Meeks and seconded by Wulff

"That the Metropolitan Council table Business Item 2009-323 – Settlement of Litigation: *MOAC Land Holdings, LCC v. Metropolitan Airport Commission and the Metropolitan Council"*

2009-323 - Settlement of Litigation: MOAC Land Holdings, LLC v. Metropolitan Airport Commission and the Metropolitan Council

It was moved by Scherer and seconded by Wittsack

"That the Metropolitan Council authorize the Regional Administrator to settle the matter entitled *MOAC Land Holdings, LLC v. Metropolitan Airport Commission and the Metropolitan Council* on terms consistent with the discussion that occurred during the closed portion of the Management Committee meeting and to authorize the Regional Administrator and the Metropolitan Council's attorneys to take all actions necessary or appropriate to finalize a settlement of the above-entitled matter."

Motion carried on the original motion.

2009-343 SW - Appointment of General Counsel

It was moved by Scherer and seconded by Leppik

"That the Metropolitan Council recommend the Metropolitan Council appoint Don Mueting to the position of General Counsel."

The Council's Legal Department is supervised by a General Counsel. By statute, the General Counsel is appointed by the Council's governing body and serves at the pleasure of the Council. The General Counsel position currently is vacant. The vacancy was publicly advertised and several applicants were interviewed by a six-member panel consisting of Chair Peter Bell, the chairs of the four standing committees, and Regional Administrator Tom Weaver. The panel is recommending Don Mueting for the General Counsel position. In conjunction with the process of filling the vacant General Counsel position, Dave Theisen of the Legal Department has been appointed Deputy General Counsel.

2009-313 - Authorization to Execute Agreement with MVTA for the Cedar Avenue Lakeville BRT Express Service

"That the Metropolitan Council authorize the Regional Administrator to execute a sole source agreement with Minnesota Valley Transit Authority to provide Cedar Avenue Lakeville BRT express service in an amount not to exceed \$650,000."

"That the Metropolitan Council allocate the \$21 million in 2009 Transit Capital Improvement Program state G.O. bonds per Attachment A."

Report of the Community Development Committee

<u>2009-321 SW</u> - City of Minneapolis Request to Amend the End Project and Extend the Grant Agreement Expiration Dates for Longfellow Station Grants SG006-162,SG007-041 and SG007-115

It was moved by Steffen and seconded by Meeks

" That the Metropolitan Council approve the request by the City of Minneapolis to extend the terms of the Livable Communities grants for the Longfellow Station project and recommend that the Metropolitan Council:

(1) Authorize its Community Development Director to execute amendments to Grant numbers SG006-162, SG007-041 and SG007-115 that:

(a) Permit the Grantee to use the grant funds for the modified project as presented to the Review Panel; and

(b) Extend the expiration dates of Grant Numbers SG006-162 (from December 31, 2009, to December 31, 2011), SG007-041 (from September 30, 2009, to September 30, 2010), and SG007-115 (from December 31, 2009, to December 31, 2011).

(2) This action is conditioned upon the following:

(a) All three grants will terminate as of December 31 2009 if a copy of an executed developer's agreement is not delivered to Metropolitan Council staff before December 31 2009;

(b) The Grant-Funded Activities of the TBRA grant SG007-041 must commence before March 31, 2010 and no grant funds will be disbursed until that cleanup work commences;

(c) Work on the project activities funded by LCDA grant SG006-162 must commence no later than June 30, 2010, and be completed by December 31, 2011;

(d) No grant funds will be disbursed for LCDA Grant Numbers SG006-162 or SG007-115 until construction on the mixed use building has begun, and development of the project must commence by December 31, 2010 and be complete by December 31, 2011;

(e) The City must submit a schedule to the Metropolitan Council that shows all construction will be completed by December 31, 2011; and

(f) The City must submit evidence of full project funding by March 31, 2010."

Chair Bell reported:

- the Metropolitan Council, Humphrey Institute and McKnight Foundation hosted a Regional Policy Conference earlier today. Bruce Katz, Vice President and Director of the Metropolitan Policy Program of the Brookings Institute presented the key note address;
- the Council was served a Summons and Complaint: Regents of the University of Minnesota v. Metropolitan Council in which the University alleges the Council failed to adequately address environmental effects of the proposed Central Corridor Light Rail Transit (CCLRT) project and take adequate mitigation measure to protect the University during construction and when the CCLRT operates. Council will continue negotiating with the University;

Chair Bell thanked Dave Theisen for serving as interim General Counsel these past months and congratulated him on his new position as Deputy General Counsel.

- the CCLRT Community Advisory Committee met to discuss right-of-way issues;
- she attended a portion of the 2009 Metro Transit Roadeo and complimented transit drivers for their expertise in the bus operators skills and safety competition.
