Background

Dakota County will receive \$3,287,000 in state bond funds (from the \$21 M allocated to the Met Council in 2009) to conduct work related to bus lane improvements along Cedar Avenue in Apple Valley and Lakeville.

RCRRA will receive \$500,000 in state bond funds from the 2009 amount allocated to the Met Council to match federal funds to acquire land for the Union Depot multimodal hub in St. Paul.

SouthWest Transit will receive \$1,393,750 in RTC funds to match an awarded CMAQ federal grant to construct a park and ride facility at Market Boulevard in the City of Chanhassen.

The City of Shakopee will receive \$292,000 in RTC funds to match federal funds from MnDOT to construct a surface park and ride at CR16 and CR21 in Shakopee.

Rationale

These grants allow regional transit providers and transit capital sponsor agencies to fund transit capital projects using state bonds, regional transit capital funds, and federal funds distributed by the Metropolitan Council.

Funding

The funding for these grants includes \$3,787,000 in state bond funds, \$1,773,250 in regional transit capital bond funds, and \$350,000 in federal funds for projects that are included in the 2009 Authorized Capital Program.
