Background

The service availability charge (SAC) pays for reserve capacity costs of the wastewater system. It has been levied since 1973 for new connections or other increased demand to the system.

Public meetings were held August 11 and 13 to solicit public comments on proposed changes in: 1) SAC for outdoor spaces and 2) the methodology for computing reserve capacity to be paid through SAC. In both cases some controversy arose and a task force was suggested.

The task force will evaluate 1) current and proposed methods of reserve capacity estimation and recommend a method for Council consideration and 2) Council fees for reserve capacity funding (that is, SAC criteria and discounts) and recommend changes, clarifications, enhancements, and implementation methods. It is hoped that task force recommendations will be available to the Council before the end of 2010.

Rationale

When the Council adopted its 2010 wastewater rates in September, Council members indicated support for a task force to review these issues.

Funding

The administrative costs, including a possible use of consulting, for the task force will be minor and can be paid from within the 2009 and proposed 2010 operating annual budgets of MCES.

Known Support / Opposition

Metro Cities and several customer communities asked for a task force to study these matters at the public meetings. There is no known opposition.
