Subject: North Mississippi Regional Park Grant, Minneapolis Park & Rec.

Proposed Action:

That the Metropolitan Council authorize a grant of \$425,535 comprised of interest earnings on park grant accounts to the Minneapolis Park & Recreation Board for the following purposes:

- --\$225,535 to reimburse the Park Board for local funding of trail, picnic and parking area improvements in the 49th Avenue to 53rd Avenue North section of North Mississippi Regional Park.
- --\$200,000 to finance design/engineering studies and construction regarding parking, pedestrian-bicycle facilities and additional recreation amenities in the 47th Avenue North area of North Mississippi Regional Park as called for in the Metropolitan Council-approved master plan.

Summary of Committee Discussion / Questions:

The Committee discussed the history of the legislation that required the Metropolitan Council's interest earnings on its park grants to be used solely for the acquisition and development of North Mississippi Regional Park.

The Committee unanimously approved the recommendation.

Proposed Action

That the Metropolitan Council authorize a grant of \$425,535 comprised of interest earnings on park grant accounts to the Minneapolis Park & Recreation Board for the following purposes:

--\$225,535 to reimburse the Park Board for local funding of trail, picnic and parking area improvements in the 49th Avenue to 53rd Avenue North section of North Mississippi Regional Park.

--\$200,000 to finance design/engineering studies and construction regarding parking, pedestrian-bicycle facilities and additional recreation amenities in the 47th Avenue North area of North Mississippi Regional Park as called for in the Metropolitan Council-approved master plan.

Background

Legislation enacted in 1985 and 1987 requires the Metropolitan Council to grant interest earnings on its park grant accounts towards the acquisition and development of North Mississippi Regional Park. The Minneapolis Park and Recreation Board (MPRB) has requested a grant of \$425,535 to reimburse the Park Board \$225,535 for its local funding of trail, picnic and parking improvements between 49th and 53rd Avenues North in the park that the Metropolitan Council authorized on January 28, 2009 under agenda item 2009-4. The Park Board also requests \$200,000 for design/engineering studies regarding parking, pedestrian/bicycle facilities and additional recreation amenities in the 47th Avenue North area of the park.

Rationale

State law requires the Metropolitan Council to spend the interest it earns on park capital improvement bonds for the acquisition and development of North Mississippi Regional Park. The requested reimbursement of \$225,535 is consistent with the Council's action under agenda item 2009-4. The additional \$200,000 is available in Council interest earnings to finance design/engineering studies regarding parking, pedestrian-bicycle

facilities and additional recreation amenities in the 47th Avenue North area of the park as called for in the Metropolitan Council-approved master plan.

Funding

The \$425,535 grant is financed with interest earnings on the Metropolitan Council's park bond accounts. This amount is available to finance this grant.

Known Support / Opposition

The Metropolitan Parks and Open Space Commission reviewed this request at its meeting on November 5. The Commission amended the staff recommendation by inserting "and construction" as an eligible expenditure for the \$200,000 portion of the grant. This would allow any funds remaining after design/engineering studies to be used for construction purposes. The MPRB staff supported the amended recommendation. There is no known opposition to this proposal.

INTRODUCTION

Legislation enacted in 1985 and 1987 requires the Metropolitan Council to grant interest earnings on its park grant accounts towards the acquisition and development of North Mississippi Regional Park. The Minneapolis Park and Recreation Board (MPRB) has requested a grant of \$425,535 to reimburse the Park Board \$225,535 for its local funding of trail, picnic and parking improvements between 49th and 53rd Avenues North in the park that the Metropolitan Council authorized on January 28, 2009 under agenda item 2009-4; and to provide \$200,000 for design/engineering studies regarding parking, pedestrian/bicycle facilities and additional recreation amenities in the 47th Avenue North area of the park. This development is consistent with the Metropolitan Council-approved master plan. The Council has sufficient interest earnings to finance the grant. (See Attachment 1, letter from Andrew Lesch, Mpls. Park & Rec. Board). A map of the park is on Attachment 2.

This memorandum contains a review of the request under applicable terms of the legislation.

AUTHORITY TO REVIEW

Laws of Minnesota 1985, First Special Session, Chap. 15, Sec. 5, Subd. 2 (b), plus Laws of Minnesota 1987 Chapter 384, Article 3, Sec. 45, and Laws of Minnesota 1998, Special Session, Chapter 1, Article 3, Sec. 12 direct the Metropolitan Council to establish a separate account of interest it earns on park bonds and to grant funds from that account for the acquisition and development of North Mississippi Regional Park.

BACKGROUND and ANALYSIS:

From 1985 to the present, the Metropolitan Council has authorized 18 grants totaling \$13,901,360 to acquire and develop North Mississippi Regional Park in accordance with the legislation cited above. Of this amount \$12,701,360 is interest earnings on bonds issued by the Council for regional park capital improvements. Details on the grants awarded for the park are shown in Attachment 3.

In 1998 the Legislature expanded the boundary of North Mississippi Regional Park to include a trail segment along 49th Avenue. The trail portion extends approximately one-mile west of the main park to Humboldt Avenue and Shingle Creek. In 2003 the Metropolitan Council approved an amended master plan for North Mississippi Regional Park to include trail development along 49th Avenue consistent with the legislation.

In 2002 the MPRB proposed additional future development projects for North Mississippi Regional Park that were estimated to cost \$3,260,000 at that time. Details of the projects and what has been funded for some of those projects are shown on **Attachment 4.** Discussions with legislators to cap the open ended appropriation for this park were conducted. Since the actual costs for the additional improvements would be dependent on future inflationary factors there was no support for proposing a cap in the amount that could be granted for the park.

In January 2009, the Metropolitan Council approved consideration of reimbursement of up to \$300,000 to the MPRB to add a dock, restroom, picnic shelter, pavement and site improvements at the Camden Boat Launch in North Mississippi Regional Park when that amount of interest had been earned on the Council's park bonds in accordance with State law (Agenda item 2009-4). That work is nearing completion at a cost of \$225,535. The

MPRB would like to be reimbursed for that expense plus obtain \$200,000 for design/engineering studies regarding parking, pedestrian/bicycle facilities and additional recreation amenities in the 47th Avenue North area of the park. This proposed development is consistent with the Metropolitan Council-approved master plan.

CONCLUSIONS

- 1. State law requires the Metropolitan Council to spend the interest it earns on park capital improvement bonds for the acquisition and development of North Mississippi Regional Park.
- 2. The requested reimbursement of \$225,535 is consistent with the Council's action under agenda item 2009-4. The additional \$200,000 is available in Council interest earnings to finance design/engineering studies regarding parking, pedestrian-bicycle facilities and additional recreation amenities in the 47th Avenue North area of the park as called for in the Metropolitan Council-approved master plan.

RECOMMENDATION

That the Metropolitan Council authorize a grant of \$425,535 comprised of interest earnings on park grant accounts to the Minneapolis Park & Recreation Board for the following purposes:

- --\$225,535 to reimburse the Park Board for local funding of trail, picnic and parking area improvements in the 49th Avenue to 53rd Avenue North section of North Mississippi Regional Park.
- --\$200,000 to finance design/engineering studies regarding parking, pedestrian-bicycle facilities and additional recreation amenities in the 47th Avenue North area of North Mississippi Regional Park as called for in the Metropolitan Council-approved master plan.

Dear Arne:

As per your e-mail dated 3-23-09, I understand \$425,535 in the North Mississippi Fund (Council Interest Earnings) is now available for a new grant. I request, therefore, a new grant in the amount of \$425,535 with a 3 year term for use in North Mississippi Park. The requested grant time period would be from January 30, 2009 thru January 30, 2012.

The funds are to be used for re-imbursement of trail, picnic and parking improvements from 49th Ave. N. to 53rd Avenue North. The project has a re-imbursement agreement approved by the Metropolitan Council on January 28, 2009. The agreement was in response to my request dated 11-24-2008 to cover additional costs to the project to maximize the project outcome in the area from 49th Ave North to 53rd Ave North. The request stated additionally, as funds permit, toilet and picnic facilities would be added at the Camden boat launch area at the 42nd Ave.


We estimate about \$225,535 in funds are needed for the re-imbursement of the project nearing completion. The balance of \$200,000 would be available to prepare a study for the next phase from the Camden Boat Launch area @42nd Ave to 49th Ave. North. More specifically our study project would address circulation for parking, pedestrians, and bicyclists, and additional recreation opportunities in the 47th Avenue North area. As the park has seen growth in usage, additional parking, looped drives, outdoor gathering spaces, restrooms, shelters, and landscaping would enhance the publics' enjoyment of the regional park.

These improvements are consistent with the Master Plan suggested development Action items. Action 6 states "Construct a hike bike trail from 53rd Ave to the Camden Bridge". Action 7. states "Develop a park entrance at 49th Ave. and a recreational node between the 47th Avenue and 51st Avenue areas" (parking, restrooms, a picnic area shelter, open play area, and shoreline fishing). Action 9 states "Upgrade and improve boat access south of Camden Bridge".
