- Authorize the following townships to put their 2030 Comprehensive Plan Updates into effect: Benton, Camden, Dahlgren, Hancock, Hollywood, Laketown, San Francisco, Waconia, Watertown and Young America.
- 3. Adopt the advisory comments for transportation and land use presented in those sections of the review record.
- Accept the revised forecasts as shown in Table 1, 2 and 3 of this report.
- Approve Laketown Township's Tier II Comprehensive Sewer Plan.

Summary of Committee Discussion / Questions:

Community Development Committee

Planning analyst and sector representative Jim Uttley presented the staff report and proposed actions to the Community Development Committee. Committee chair Steffen asked about Table 4 in the staff report which shows a decline in the acreages of open water and wetlands between 2008 and 2030. Staff responded that the decline is the result of the annexation of open water and wetland into cities within the county. The Committee voted unanimously to recommend that the Council adopt the attached Advisory Comments and Review Record, and proposed actions noted above.

Environment Committee

Council Member Wittsack asked for clarification as to why the plan forecasts 391 acres of single family residential units in 2020 but notes the count as 0 for 2030. Staff stated that this reflects the total annexation of the township into the surrounding communities somewhere between 2020 and 2030. After the annexation, those acres would then be counted as residential acres in whatever community they were annexed into.

Council Member Leppik asked why the county's plan identified forecasts for the individual townships. Staff stated that the county has the planning authority for each of the ten townships located within its jurisdiction. Therefore, the county plan summarizes the growth forecasts for each township and, collectively, these represent the total growth forecast for the county. Leppik asked why the item specifically singles out Laketown Township. Staff stated that because Laketown Township is the only township of the ten in Carver County that owns and operates its own wastewater collection system, it is the only township in the

county that is required by statute to develop and submit to the Council for approval a Tier II sewer plan.
Motion to approve Laketown Township's Tier II Comprehensive Sewer Plan was made, seconded, and passed unanimously.

Carver County & Townships 2030 Comprehensive Plan Update and Laketown Township Tier II Comprehensive Sewer Plan

The following Advisory Comments are part of the Council action authorizing the County and its townships to implement their 2030 Comprehensive Plan Updates ("Update") and approving the Laketown Township Tier II Comprehensive Sewer Plan:

Community Development Committee

- 1. The County and its townships are reminded that Minnesota Statutes 473.864 requires them to:
 - (a) Formally adopt the Update within nine months following Council action
 - (b) Submit two copies to the Council, and
 - (c) Submit a copy of the County Board and township boards resolutions adopting the Update following final action to the Metropolitan Council.
- 2. Local governmental units must adopt official controls as described in their adopted comprehensive plans and must submit copies of the official controls to the Council within 30 days after official controls are adopted. (Minn. Stat. § 473.865, subd. 1).
- 3. Local governmental units cannot adopt any official controls or fiscal devices that conflict with their comprehensive plans or which permit activities in conflict with the Council's metropolitan system plans. (Minn. Stat. §§ 473.864, subd. 2; 473.865, subd. 2). If official controls conflict with comprehensive plans, the official controls must be amended within nine months following amendments to comprehensive plans. (Minn. Stat. § 473.865, subd. 3).

Environment Committee

- The Council-approved Tier II Comprehensive Sewer Plan becomes effective after the Update receives final approval by the Laketown Township Board of Supervisors. After the Tier II Sewer Plan becomes effective, the Township may alter, expand or improve its sewage disposal system consistent with the Council-approved Tier II Sewer Plan and the Update.
- 2. A copy of the Laketown Township Board of Supervisors Resolution adopting its Update, including the Tier II Sewer Plan, must be submitted to the Council.

Background

Carver County is located in the southwestern portion of the Twin Cities metropolitan area. Figure 1 shows the general location of Carver County and its subdivisions, and the County's 2030 Regional Development Framework (RDF) designation, which identifies Carver County townships as Agricultural, except for Laketown Township which is designated "diversified rural." Figure 2 shows existing and planned regional systems in Carver County.

Like most counties in the Region, Carver County experienced substantial growth during the late 1990's and early 2000's. According to the 2000 census, the county (including the cities) had grown about 247% (22,000 people) between 1990 and 2000. The Council forecasts that the county will grow by nearly 85,000 people and 34,400 households between the years 2010 and 2030.

The county contains a wide variety of communities and lifestyles. In 2007, the cities of Chanhassen, Chaska, Victoria and Waconia were home to over 62,000 people. The county also has seven rural growth centers, Carver, Cologne, Hamburg, Mayer, New Germany, Norwood Young America and Watertown. The remainder of the county is the 10 townships, which provide extensive agriculture, rural single-family residential, and some limited commercial areas. The townships comprise about 295 square miles, of that about two thirds is in agricultural and farmstead uses, and the remainder in general rural uses.

Carver County is responsible for planning and zoning in the unincorporated (township) areas of the County. The Update fulfills the Metropolitan Land Planning Act (MLPA) and system statement requirements for the townships of Benton, Camden, Dahlgren, Hancock, Hollywood, Laketown, San Francisco, Waconia, Watertown and Young America.

REVIEW RECORD

Review of the Carver County & Townships 2030 Comprehensive Plan Update

STATUTORY AUTHORITY

The Metropolitan Land Planning Act (MLPA) requires local units of government to submit comprehensive plans (plans) and plan amendments to the Council for review and comment (Minn. Stat. § 473.864, Subd. 2). The Council reviews plans to determine:

- Conformance with metropolitan system plans,
- Consistency with other adopted Plans of the Council, and
- Compatibility with the Plans of other local jurisdictions in the Metropolitan Area.

The Council may require a local governmental unit to modify any plan or part thereof if, upon the adoption of findings and a resolution, the Council concludes that the Plan is more likely than not to have a substantial impact on or contain a substantial departure from metropolitan system plans (Minn. Stat. § 473.175, Subd. 1).

Each local government unit shall adopt a policy plan for the collection, treatment and disposal of sewage for which the local government unit is responsible, coordinated with the Metropolitan Council's plan, and may revise the same as often as it deems necessary. Each such plan shall be submitted to the Council for review and shall be subject to the approval of the Council as to those features affecting the Council's responsibilities as determined by the Council. Any such features disapproved by the Council shall be modified in accordance with the Council's recommendations (Minn. Stat. § 473.513).

CONFORMANCE WITH REGIONAL SYSTEMS

Regional Parks

Parks and Trails

The Update is in conformance with the 2030 Regional Parks Policy Plan (RPPP). The existing regional parks system facilities in Carver County include:

State and Federal park and open space units within the County provide outdoor recreation opportunities and natural resource conservation for the public and are considered part of the regional recreation open space system. The Minnesota Department of Natural Resources operates the Luce Line State Trail, Assumption Wildlife Management Area (WMA), Patterson WMA, Raquet WMA, Schneewind WMA and the Minnesota Valley State Trail and Recreation Area. The University of Minnesota manages the Minnesota

Landscape Arboretum, and the US Fish and Wildlife Service manages the Minnesota Valley National Wildlife and Recreation Area.

The Update acknowledges and plans for these regional parks system facilities. The Update proposes a trail crossing of the Minnesota River to Scott County at the Union Pacific Railroad corridor as well as an extension of the Minnesota River Bluffs Regional Trail from Chaska to Carver, with the possibility of being extended to Belle Plaine after 2030. These trails were not identified as regional trails in the *2030 Regional Parks Policy Plan*; however, the County may seek regional status for these proposed trails when the Council updates its RPPP in 2010.

Transportation

Roads and Transit

Reviewer: Ann Braden, MTS – Systems Planning, (651-602-1705)

The Update is in conformance with the Transportation Policy Plan (TPP) adopted in 2004, and addresses all the applicable transportation and transit requirements of a comprehensive plan.

Carver County is served by segments of three principal arterials: TH 7 and TH 212 which both run east-west through the county. The eastern section of TH 212 has recently been reconstructed on new alignment as a four lane freeway. An alignment for a new, future TH 41 Minnesota river crossing connecting TH 212 and TH 169 in Scott study is under study. However, there are no plans to construct this bridge before 2030.

Areas of Carver County are within Market Areas III and IV. Service options for Market Area III include peak-only express, small vehicle circulators, midday circulators, special needs paratransit (ADA, seniors), and ridesharing. Service options for Market Area IV include dial-a-ride, volunteer driver programs, and ridesharing.

Advisory Comments

Functional Classification: The Update includes a "future" functional classification system (Fig. 9) that contains a number of proposed changes to the TAB's Functional Classification Map. These changes must be submitted to the TAC Planning Committee for review and approval, which is a process separate from the Comprehensive Plan Update review process.

TAZ Allocation: The TAZ allocation of population, household and employment forecasts (Table C-1) agrees with the county totals on Table 4. This includes "pending" numbers agreed upon by the Council's Research Staff. There are some slight differences in the community numbers for New Germany and combined Dahlgren Township/City of Carver, but for transportation modeling purposes, these differences are insignificant.

Transit: It would be helpful to include the following to the transit section of the introduction of the transportation chapter (p. 4):

- A description of the Transit Market Areas as described on page 12 of the transportation chapter.
- An edited description of the CART service to clarify that it is available to the general population of the county, not just seniors and the disabled.
- A statement on page 4 that acknowledges that a commuter rail line through the county is not part of the region's Transportation Policy Plan

Transit policy T-5 (p. 10) discusses the County Board's desire to coordinate transit planning and to consider commuter rail on the TCW line. The last sentence of this policy should delete the word "commuter" before "rail"; which implies that the TCW is already offering commuter service.

Aviation

The Update is in conformance with the TPP and consistent with Council Aviation policy.

Water Resources Management

Wastewater Service

Reviewer: Kyle Colvin, ES – Engineering Services, (651-602-1151)

The Update is in conformance with the 2030 Water Resources Management Policy Plan (WRMPP). The Update represents 10 Townships in Carver County, and is their guide for future growth and development through the year 2030. With the exception of Laketown, the Townships included in the Plan are entirely provided wastewater service through the use of private wastewater systems, or ISTS'. The Plan indicates continued wastewater services will be provided through the use of ISTS' through 2030, with the exception of Laketown Township. Laketown Township is party to an orderly annexation agreement which will ultimately result in the annexation of the Township into the cities of Chaska, Victoria, and Waconia before the year 2030.

With the exception of Laketown, the remaining nine Townships included in the Plan do not propose nor anticipate requesting connection to the Regional Wastewater Disposal system within the 20-year planning period. Therefore, those nine Townships are not required to submit for approval a Tier II Comprehensive Sanitary Sewer Plan.

The Metropolitan Council does not have plans to provide wastewater services to any of the Townships included in the Plan within the 2030 planning period, with the exception of Laketown.

Tier II Comments (Laketown Township)

Reviewer: Kyle Colvin, ES – Engineering Services, (651-602-1151)

The Metropolitan Council Environmental Services currently provides wastewater treatment services to the Township. Wastewater generated within the Township is conveyed to and treated at the Metropolitan Council's Blue Lake Wastewater Treatment Plant in Shakopee. The Township is provided wastewater conveyance service through interceptor's 7508, 9204, and 7020 (Crown College). The Update projects that the City will have 220 sewered households and no sewered employees by 2020. The Township will be annexed into the cities of Chaska, Victoria, and Waconia before the year 2030. The Metropolitan Disposal System with its planned scheduled improvements has or will have adequate capacity to serve the Township's growth needs as identified in the Plan.

The Update provides sanitary flow projections in 10-year increments. The rationale, for the projections, is given in the Update and determined appropriate for planning for local services.

Laketown Township is not currently identified as a community impacted by wet weather occurrences. The Update however does include a description of an I/I reduction plan which includes inspection and routine maintenance of the sanitary sewer system. The Township has adopted an ordinance that prohibits the connection of sump pumps, rain leaders, and passive drain tile from the sanitary sewer system.

Surface Water Management

Reviewer: Judy Sventek, ES – Water Resources Assessment (651-602-1156)

The Update is in conformance with the WRMPP for local surface water management. Carver County is responsible for watershed management planning for the Carver County Watershed Management Organization (CCWMO), which covers most of the county. The Board of Water and Soil Resources approved the Carver County Watershed Management

Organization's watershed management plan in 2001. Carver County is in the process of updating this plan and hopes to have a new plan adopted in 2010.

Carver County is responsible for planning for the townships. All cities and townships within the Carver County Watershed Management Organization (CCWMO) planning area were required to prepare local water management plans in response to the County's watershed management plan update in 2001. Since the Update covers the planning requirements for Benton, Camden, Dahlgren, Hancock, Hollywood, Laketown, San Francisco, Waconia, Watertown, and Young America Townships, the Update needed to fulfill the local surface water management plan requirement for those townships. All of the townships have adopted the 2001 CCWMO plan as their local surface water management plan. This fulfills the requirement for a local surface water management plan for these townships. However, when the new CCWMO plan is adopted, the townships will need to either adopt that new plan as their local surface water management plan or prepare a new local surface water management within two years.

CONSISTENCY WITH COUNCIL POLICY

Forecasts

Reviewer: Todd Graham, CD - Research, (651-602-1322)

The Update is inconsistent with Council's forecasts and regional policy contained in the System Statement sent to the County. However, the County's planning includes a forecast revision to reflect the post-annexation population, households and employment of Dahlgren Twp and Carver city. Council staff finds this revision reasonable and acceptable. With approval of the County's Update, the Council's forecasts for Dahlgren Twp and the City of Carver city will be revised to represent post-detachment and post-annexation levels:

2030 Regional Development Framework and Land Use

Reviewer: Lisa Barajas, CD – Local Planning Assistance, (651-602-1895)

The Update is consistent with the *2030 Regional Development Framework*, which designates areas under County planning jurisdiction as Agricultural, with eastern portions of Laketown Township designated as Diversified Rural. The Update directs growth to occur in municipalities where urban services already exist.

The Update guides the lands designated in the cities' comprehensive plans as receiving sewer service by 2030 as Transition Policy Areas. The Transition Policy Areas are intended to define that the areas cities will need for future expansion, prohibit interim large lot residential development and land uses not compatible with future land use, and provide for the efficient growth of the cities and the economical extension of services to developing areas. Lands within the Transition Areas are guided at densities no greater than 1 unit per 40 acres. The Update indicates that approximately 30,000 acres of land within the County's jurisdiction falls within the Transition Areas category and is planned to be annexed into municipalities by 2030, as shown in Table 4 below.

The Update indicates that the majority of the land within the townships falls under the Agricultural Policy Area, which limits residential densities to 1 unit per 40 acres with allowances for limited higher densities in amenity areas and conservation incentives. This area is intended to preserve long-term agricultural land in farmable parcels. Within the

Agricultural Policy Area, the Update provides for four residential density options: Option 1 at 1/40 density with no additional density in amenity areas, Option 2 for Wooded/Lakeshore Lots, Option 3 for high amenity areas, and Option 4 that provides Conservation Incentive.

Option 1 applies to Benton, Hancock, Hollywood, and Young America Townships and does not permit additional density beyond the base 1/40 density. Option 2 for Wooded/Lakeshore Lots applies to Camden, Dahlgren, Laketown, and Waconia Townships. This Option allows a base density of 1/40 with limited additional development based on building eligibilities, which are determined by existing residential lots of record. Option 3 applies to San Francisco and Watertown Townships and allows additional development in amenity areas, such as along lakeshore or in wooded areas, with a maximum density of one unit per 10 acres. Option 4 only applies to San Francisco Township and provides additional densities as an incentive for property owners to protect, preserve, enhance, or restore natural resources on their properties.

The Update also recognizes Rural Service Districts as existing small hamlets that have developed over the years and typically serve a neighborhood purpose or accommodate specialized facilities. The Update identifies Assumption, Bongards, East Union, Gotha, Maple, Hollywood Station, and Hollywood (Sports Complex) as Rural Service Districts. This designation limits residential development to that indicated in each of the Township's selected Agricultural Policy Area development option and instead provides specific development standards to enhance and support the role of each of the districts in the community.

Advisory Comment

The Update identifies three Opportunity Areas including multi-modal sites along the Twin Cities Western (TCW) railroad, the Highway 7/CSAH 10 intersection in Watertown Township, and an area in northeast Dahlgren and south southwest Laketown Townships with potential for transit and transit-related development. The Update indicates that varying degrees of study had been undertaken for each of these sites and their impacts on the community. The County is advised that prior to development in any of these areas, the County will need to submit comprehensive plan amendments to guide future land uses for these areas to the Council for review.

Housing

Reviewer: Linda Milashius, CD – Livable Communities, (651-602-1541)

The housing element of the Carver County CPU is complete and fulfills the housing planning requirements of the MLPA. The Update provides a county-wide assessment of the housing stock, identifies affordable and life-cycle housing issues and needs, provides goals and strategies to address those needs, as well as implementation tools and programs that the County will use or make available to assist its cities and townships in addressing local housing needs. The Carver County Community Development Agency (CDA) through collaboration and partnering shall provide affordable housing opportunities for Carver County residents through construction of new housing and maintenance of existing housing and foster Economic and Community Development to cities in Carver County. The CDA is committed to providing a balanced housing supply to meet the varied needs of residents of all ages, lifecycle stages, household sizes, and socio-economic circumstances in all geographic areas of Carver County.

Individual Sewage Treatment Systems (ISTS) Program

Reviewer: Jim Larsen, CD – Local Planning Assistance, (651-602-1159)

The Update is consistent with the WRMPP for ISTS. It indicates that there are approximately 4800 systems serving households and businesses in the County. Ordinance Chapter 52 is used to regulate ISTS in the County. All ISTS in Carver County

townships and cities are overseen by County staff with the exception of the systems operating in the City of Chanhassen. The County's program is consistent with MPCA Rules and Council policy requirements.

Water Supply

Reviewer: Sara Bertelsen, ES – Water Supply Planning, (651-602-1035)

Neither the county nor any of the 10 townships operate a public water supply system, and therefore are not required to complete water supply plans.

Resource Protection

Historic Preservation

The Update addresses Historic Preservation as required by the MLPA.

Solar Access Protection

Reviewer: Jim Uttley, CD – Local Planning Assistance, (651-602-1319)

The Update addresses solar access protection as required by the MLPA.

Aggregate Resources Protection

The Update contains a section on aggregate resources protection as required by the MLPA. It indicates, consistent with Minnesota Geological Survey Information Circular 46 data, the presence of viable aggregate resources in the County. The majority of the resources are located in the Minnesota River Valley outwash area within San Francisco Township and extending up into Dahlgren Township. The resources in San Francisco Township are characterized by woods, wetlands, and bluffs, which would be negatively affected by aggregate extraction. San Francisco Township has adopted an ordinance regulating aggregate extraction that is more extensive and restrictive than the County's to address issues specific to the Township. Mining currently takes place in eastern Dahlgren Township, within its Transition Area. Historically, mining of smaller, isolated deposits occurred in Laketown Township. Deposits within Camden, Hollywood, and Watertown Townships are typically somewhat larger in areal size, but shallower and of lower quality. Adequate policies are in place in the Update to maintain the ability to access aggregate resources in the future, while meeting other land use and natural resource preservation goals.

Figure 1 - Location Map with 2030 Regional Development Framework Planning Areas, Carver County




Figure 2 - Regional Systems, Carver County




Figure 3 - Existing Land Use, Carver County CARVER COUNTY LAND USE 2008

Figure 4 - 2030 Land Use Plan, Carver County




Figure 5 - Policy Areas, Carver County
