Proposed Action

That the Metropolitan Council ratify the attached *Justification for and Declaration of Emergency* for Rosemount Forcemain 9208 repair.

Background

On December 22, 2009, a leak was discovered in the Rosemount Forcemain south of County Road 42, west of Highway 55. Staff estimates that approximately 100 gallons leaked before flow was diverted to a second forcemain.

Ames Construction, the original construction contractor, has been asked to excavate and investigate. If the cause of the problem relates to original construction, MCES expects that Ames and its insurance will be responsible for correction of the defect. The excavation is scheduled to begin the week of February 8.

Rationale


The Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and placed on a following Council consent list for formal ratification.

Funding

Estimated cost for the investigation and repairs is \$100,000.
