Call to Order and Approval of Agenda

A quorum being present, the Chair called the regular meeting of the Metropolitan Council to order at 4:08 p.m. It was moved by Pistilli, seconded by Hilker, to approve the agenda. Motion carried.

Minutes

It was moved by Broecker, seconded by Leppik, to approve the minutes of the Metropolitan Council Meeting of February 24, 2010. Motion carried.

Public Invitation

<u>Tim Olson, MCES employee</u>, spoke about his dissatisfaction with Met Council management and the grievance process relating to personnel issues.

Barb Toman, Acting Executive Director, Transit for Livable Communities (TLC), spoke of the Twin Cities expanding regional highway system that, in turn, requires additional funds to maintain the additional pavement and bridges. TLC suggests that the I-169/494 interchange project be scaled back, and the savings be spent on lower cost strategies in that corridor.

(comments)

Will Schrooer, State Policy Director, Smart Growth America, urged the Council to reconsider their action supporting funds for the construction of the I-169/494 interchange project and direct some of those funds to improving the region's highways. Road improvements and safety should be a higher priority.

<u>2010-67 - Authorization to Award Contract for Dakota County Transit Link Service</u>
It was moved by McFarlin and seconded by Wolter

"That the Metropolitan Council authorize the Regional Administrator to execute a five year contract with DARTS to provide Transit Link dial-a-ride service in Dakota County beginning May 2010 in an amount not to exceed \$5,467,534."

Motion carried.

<u>2010-69 SW - Central Corridor Light Rail Transit Advanced Traffic Improvements,</u> <u>Project 8453</u>

It was moved by McFarlin and seconded by Peterson

"That the Metropolitan Council authorize the Regional Administrator to award and execute a contract with the lowest responsive and responsible bidder, Graham Construction Services, for the Central Corridor Light Rail Transit (CCLRT) Advanced Traffic Improvements in Minneapolis, Minnesota at a cost of \$3,616,440. Award of this contract is contingent upon the receipt of a Letter of No Prejudice (LONP) from the Federal Transit Administration (FTA) expected prior to full Council action March 24, 2010, and executed by the University of Minnesota of the required temporary construction easements."

Council Member Wolter recused himself from any discussion and vote on this item. Motion carried.

2010-83 - Metro Mobility Demand Contract Recommendations

It was moved by McFarlin and seconded by Wittsack

"That the Metropolitan Council authorize the Regional Administrator to execute the following two contracts for the operation of Metro Mobility demand transportation services for the term July 1, 2010 through June 30, 2015 with:

- Transit Team, Inc., of Minneapolis, Minnesota for operation of Zone 1 in an amount not to exceed \$78,170,518; and
- 2. First Transit Inc., of Cincinnati, Ohio for operation of Zone 2 in an amount not to exceed \$55,061,552."

<u>2010-107 SW - Authorization to Submit Grant Application for Minnesota Department of Transportation Trunk Highway Transit Improvements</u>

"That the Metropolitan Council authorize the Regional Administrator to submit four grant applications for Minnesota Department of Transportation (MnDOT) Trunk Highway Transit Facility Improvements in the amount of \$15,000,000.

<u>2010-114 SW - Authorization to Purchase 11 Sixty-Foot Articulated Transit Buses</u> It was moved by McFarlin and seconded by Leppik

"That the Metropolitan Council:

- 1. rescind the authorization granted in Business Item 2009-433 to purchase 11 replacement articulated buses from King County Transit in Washington state, and
- 2. authorize the Regional Administrator to execute a purchase agreement with New Flyer of America using the State of Minnesota Contract No.

442668 for the purchase of eleven replacement articulated buses in an amount not-to-exceed \$6,900,000, contingent on satisfactory results from the Pre-Award Buy America Audit."

<u>2010-88 - City of Lake Elmo's Request for Temporary Relief from Wastewater Inefficiency Fees, Resolution No. 2010-08</u>

It was moved by Leppik and seconded by Scherer

"That the Metropolitan Council adopt the attached resolution, granting the City of Lake Elmo temporary relief from the Wastewater Inefficiency Fee imposed under Council Resolution No. 2005-20, and authorizing its Regional Administrator to negotiate and execute a binding Memorandum of Understanding with the City consistent with the attached resolution."

Motion carried.

Chair Bell acknowledged the presence of Lake Elmo Mayor Dean Johnson and thanked him for his leadership and cordial working relationship with the Council.

2010-95 - Adoption of the Metropolitan Water Supply Plan

It was moved by Leppik and seconded by Peterson

"That the Metropolitan Council approve the Metropolitan Area Master Water Supply Plan."

The Metropolitan Area Master Water Supply Plan was presented by Keith Buttleman, Assistant General Manager, Environmental Quality Assurance (EAQ) and Chris Elvrum, Manager, Water Supply Planning. The plan is the compilation of five years work as directed in Minn. Statute Sec. 473.1565 that the Metropolitan Council "carry out planning activities addressing the water supply needs of the metropolitan area" including the development of a master water supply plan for the metro area.

Chair Bell noted the development and adoption of the Water Supply Plan is very important to the region and will be considered a legacy activity of this Council. Councilmember Leppik, vice chair of the Water Supply Advisory Committee, acknowledged the work of Buttleman, Elvrum, Sara Smith and Lanya Ross, EAQ, for their commitment and dedication to this major initiative.

1. Authorize the City of Lake Elmo to put its 2030 Comprehensive Plan Update into effect.

2. Advise the City to:

- a. Revise the Land Use element of the Update upon the City's selection of a development scenario for the Village Area and to submit a comprehensive plan amendment to the Metropolitan Council for review of the land use revision.
- b. Revise the Update, when the Land Use element of the Update is revised and submitted to the Metropolitan Council for review, to guide the inholdings in Lake Elmo Park Reserve as parks and open space, or a comparable land use designation, on the City's 2030 Land Use Plan map.
- c. Implement the advisory comments in the Review Record for Transportation, Aviation, Surface Water Management, Housing, and Community and Individual Sewage Treatment Systems;
