Proposed Action:

That the Metropolitan Council approve a budget reallocation in support of the Livable Communities Demonstration Account (LCDA) grant (grant number SG007-117) to the City of Saint Paul for the Dale Street Village project (now known as Frogtown Square).

Summary of Committee Discussion / Questions:

Livable Communities Manager, Paul Burns presented an overview of the City's request, which is to restructure the project budget for a more efficient utilization of funds. The Livable Communities grant agreement allows budget reallocations of up to 20% of any given line item. A larger reallocation requires approval of the Metropolitan Council's governing body.

After one question confirming that the funding sources and amounts had shifted, Committee approved the Proposed Action unanimously.

Proposed Action

That the Metropolitan Council approve a budget reallocation in support of the Livable Communities Demonstration Account (LCDA) grant (grant number SG007-117) to the City of Saint Paul for the Dale Street Village project (now known as Frogtown Square).

Background

The City of St. Paul was awarded a Livable Communities Demonstration Account (LCDA) grant on December 12, 2007 to support a mixed-use redevelopment with 46 units of affordable housing geared towards seniors. Granted funds were for site assembly, demolition, site grading and soil correction. On October 7, 2009 the Council executed an amendment to administratively extend the grant to December 31, 2010.

The grantee has requested Council approval to restructure the project budget to allow for a more efficient utilization of funds. An updated schedule and budget for the redevelopment work is attached. Standard LCDA grant agreements require prior approval of the Council's governing body for any budget reallocation that exceeds 20% of any single budget line item.

Rationale

Staff supports the requested changes. As with many current, large redevelopment projects, these grant funds are a part of financing arrangements that have been forced to adapt to conform to market forces. The requested changes continue to support fund goals and have no funding impact.

Funding

The LCDA award was made in the amount of \$1,050,000.

Known Support / Opposition

Staff is unaware of any opposition.
