Call to Order and Approval of Agenda

A quorum being present, the Chair called the regular meeting of the Metropolitan Council to order at 4:06 p.m. It was moved by Wolter seconded by Wulff to approve the agenda. Motion carried.

Minutes

It was moved by Hilker seconded by Wulff to approve the amended minutes of the Metropolitan Council Meeting of May 26, 2010 and the minutes of June 23, 2010. Motion carried.

Public Invitation

Peter Hansen Roess, St. Paul, addressed the Council regarding his interest in creating an environmentally friendly community on the Twin Cities Army Ammunition Plan (TCAAP) property located in Arden Hills. The TCAAP is a U.S. Army owned facility that has long been considered prime redevelopment property.

Steve Gardner, Plymouth, expressed concern about the number of trees, Savannah Oak in particular, that are being destroyed as land is cleared to make way for community developments. Mr. Gardner believes more thoughtful consideration should be given to preserving this natural resource.

Chair Bell thanked Mr. Roess and Mr. Gardner for appearing before the Council and sharing their views.

2010-242 - 2010-2013 TIP Amendment: Dakota County, Add local funds for SP #19-623-25, and enhancement-funded SP#19-623-28 and reflect a change in scope for SP# 19-623-23 (TAB Action 2010-41)

It was moved by Steffen and seconded by Meeks

"That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2010-2013 Transportation Improvement Program (TIP) to make the following changes to these Cedar Avenue BRT related projects:

2010-244 - Initiate Eminent Domain Proceedings for the Acquisition of Parcel 5D (former Bremer Building) for Central Corridor Light Rail Transit Civil East Construction It was moved by McFarlin and seconded by Peterson

"That the Metropolitan Council authorize the initiation of eminent domain proceedings for the acquisition of the property rights for Parcel 5D (Former Bremer Building) in downtown St.Paul for the Central Corridor Light Rail Transit (CCLRT) Civil East Construction."

Motion carried, with Meeks and Wulff dissenting and Wolter recusing himself from the discussion and vote

<u>2010-245</u> - Central Corridor Light Rail Transit: Independent Testing Services during Construction

It was moved by McFarlin and seconded by Broecker

"That the Metropolitan Council Authorize the Regional Administrator to negotiate and execute a contract with Stork Twin City Testing Corporation to conduct independent testing services during construction of the Central Corridor Light Rail Transit (CCLRT) Project for an amount not to exceed \$435,000."

Motion carried, with Wolter recusing himself from the discussion and vote.

<u>2010-246 - Subrecipient Grant Agreement with Hennepin County Regional Rail Authority for the Interchange</u>

It was moved by McFarlin and seconded by Scherer

"That the Metropolitan Council Authorize the Regional Administrator to negotiate and execute a subrecipient grant agreement (SGA) with the Hennepin County Regional Rail Authority (HCRRA) passing through a \$500,000 Federal Transit

Administration (FTA) Section 5309 Bus and Bus Facilities grant for project management/administration and engineering and design activities associated with the Interchange project."

Chair Bell said the Interchange project is necessary at this time to accommodate, in a reasonable way and efficient manner, the transit projects this Administration has supported and implemented. Support for this agreement does not imply anything more than studying engineering and design activities associated with the Interchange project.

Motion carried, with Meeks and Sersland Beach dissenting.

<u>2010-247 - Central Corridor Light Rail Transit: Construction Change Order Greater than 5% for the Advanced Traffic Improvements Contract with Graham Construction Services to Cover Costs of university of Minnesota Betterments</u>

It was moved by McFarlin and seconded by Scherer

"That the Metropolitan Council authorize:

- an additional \$360,000 above the standard 5% allowable contract change order contingency to acknowledge University requested betterments under the Advanced Traffic Improvements contract;
- 2. the Regional Administrator to negotiate and execute a subordinate funding agreement with the University of Minnesota in an amount not to exceed \$360,000 for University requested betterments under the Advanced Traffic Improvements contract."

 - Hypoxia in Gulf of Mexico
- Greenhouse gases
 - Some limits for WWTP possible
 - Cap & trade => value for reduction



- Determined removal efficiencies for soluble phosphorus, nitrogen, and COD over 30 day batch feed experiment







Current Council Efforts



- Modified bioreactor operating in small greenhouse at Metro
 - Seeded with new UM algal strain reported to yield higher oil content
 - To be operated using natural light only
- Second experiment in SMB pilot plant to determine the impact of light (photosynthetically active radiation) on biomass growth, biomass characteristics, and nutrient removal performance







Biomass

- Development and demonstration of technologies for converting algal biomass to bio-fuels
- Evaluation of systems against designed technical specifications
- Evaluation and quantification of green impacts and benefits including
 - > Pollutant removal
 - > Water usage and quality
 - > Carbon sequestration
 - > Energy balance
 - > Fuel quantity and quality
- Conducting of economic and environmental life-cycle analysis



Value Proposition

- Algae grown in wastewater processes:
 - Strong co-benefit of pollution reduction
 - CO₂, phosphorus, and nitrogen available
 - Water available and free
 - Thermal energy available
 - Space available around plants
 - Expertise in dewatering (engineering and operations)
 - Laboratory/analytical availability
 - Possible market for biodiesel
 - Value recovered from cell mass reduces treatment costs
