That the Metropolitan Council authorize the Regional Administrator to execute grant agreements with Dakota County, Ramsey County Regional Railroad Authority (RCRRA), and the City of Hastings for the following projects and amounts:

Background

Dakota County will receive \$4,094,500 in State bond funds to construct bus-shoulder lane improvements on Cedar Avenue in Apple Valley and Lakeville.

RCRRA will receive \$400,000 in State bond funds to match federal funds for an analysis and preliminary engineering of railroad capacity in the east metro as part of the Red Rock corridor.

The City of Hastings will receive \$600,000 in State bonds funds to construct a park-and-ride facility along the Red Rock corridor within the City of Hastings.

Rationale

These grants allow transit capital sponsor agencies to fund transit capital projects using State bonds appropriated to the Metropolitan Council for the specific transitway.

Funding

The funding for these grants is entirely State bond funds allocated by the Legislature for the specified projects and included in the 2010 Authorized Capital Program.
