#### **Proposed Action:**

That the Metropolitan Council authorize the Regional Administrator to execute a one-year contract with two additional one-year options with First Transit, Inc. to provide regular route express and local transit service in the Rush Line Corridor area beginning in October 2010 in an amount not to exceed \$1,127,516.

#### **Summary of Committee Discussion / Questions:**

Council member Steffen asked if the Council had any dollars involved in this project. Bruce Dreier and Arlene McCarthy answered that the Rush Line Task Force was awarded federal funds for capital facilities. Those funds were transferred to the Council to fund a park and ride facility along the Rush Line Corridor and in turn the Council transferred funds to the Task Force that could be used toward operating expenses. In addition, Washington County is contributing CTIB funds and the other counties are contributing local funds.

#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to execute a one-year contract with two additional one-year options with First Transit, Inc. to provide regular route express and local transit service in the Rush Line Corridor area beginning in October 2010 in an amount not to exceed \$1,127,516.

### **Background**

This contract is for rush-hour express bus service to and from downtown St. Paul and Columbus/Forest Lake using contractor-supplied coach buses. The Rush Line Task Force has asked the Council to hold the contract on their behalf and provide contractor oversight and system integration of the service. It will operate as a demonstration route using federal funds and local funds provided by the counties. The Rush Line Task Force approved the recommended contractor at its board meeting September 8, 2010.

#### Rationale

Proposals were publicly solicited through a Request for Proposals (RFP) process and all known transit operators were directly invited to participate. The opportunity to propose was also posted on the Council's website. Two proposals were received and evaluated by a five-member evaluation panel consisting of staff from Metropolitan Transportation Services, the Rush Line Task Force, Anoka County and Washington County. The panel evaluated the proposals on the following criteria: overall transit experience; extent of experience with similar services; driver training and selection; management, administrative, financial, and technical capabilities; vehicle maintenance practices; reporting capabilities; compliance with RFP requirements; and cost.

The evaluation panel evaluated and ranked both technical proposals. The panel then evaluated the cost proposals.

The results of the evaluation are as follows:

The Evaluation Panel concluded that the proposal submitted by First Transit, Inc. with a very good technical ranking and lowest proposed cost is the most advantageous to the Council acting on behalf of the Rush Line Task Force.

The one-year demonstration cost using the competitively procured rate is \$372,948. The requested not to exceed amount of \$1,127,516 includes pricing for two one-year optional contract extensions.

#### **Funding**

Funding for this service is budgeted in the annual operating budget.
