On September 15, 2010, the Transportation Advisory Board voted to amend the 2010-2013 Transportation Improvement Program to include three high-speed rail crossing safety improvements in Dakota and Washington Counties. The three projects are:

1. SP# 19-00140: Install flashing light signals with gates at railroad crossing at TWN 18, near Hastings, Dakota County.
2. SP# 82-00141: Install medians at Belden Boulevard, Cottage Grove, Washington County.
3. SP# 82-00142: Install a four-quadrant flashing light signal system with gates and roadwork at railroad crossing on Innovation Rd., Cottage Grove, Washington County.

This TIP amendment is needed to identify new rail safety projects in the current 2010-2013 TIP in SFY 2011.
