Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute a grant agreements with SouthWest Transit and MVTA for the following projects and amounts.

Background

SouthWest Transit will receive \$275,307 in regional transit capital funds to pay for principal to accelerate scheduled payments on debt for SouthWest Village in Eden Prairie.

MVTA will receive \$330,000 in regional transit capital funds to pay off principal on the Burnsville Bus Garage and \$1,000,000 in regional transit capital funds to begin environmental, design, and engineering activities related to the expansion of the Eagan Bus Garage.

Rationale

This grant allows regional transit providers to fund transit capital projects using regional transit capital funds distributed by the Metropolitan Council.

Funding

The funding for these grants includes \$1,605,307 in regional transit capital bonds that are included in the 2010 Authorized Capital Program.
