PROJECT BACKGROUND:

- Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

This amendment is needed to identify a project scope change. The proposed change in the project scope is necessitated by the inability to obtain Union Pacific Railroad (UPRR) easements to construct the north leg of the TH 13 and Quentin Avenue intersection. The City has proposed this scope change to eliminate the need for the UPRR easements but still meet the intent of the original application.

The proposed layout plan will eliminate the north leg of the TH 13 and Quentin Ave. intersection and leaves the Lynn Ave. access point on TH 13 as a full-access intersection. Both intersections would be controlled by traffic signals in a coordinated system to provide the optimum in traffic progression on TH 13. (Figure 3)
