Proposed Action:

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2011-2014 Transportation Improvement Program (TIP) to include MnDOT SP#0280-66: I-35W North Mitigation and Design Feasibility Study from downtown Minneapolis to I-35E intersection.

Summary of Committee Discussion / Questions:

Carl Ohrn, MTS Planning Analyst, presented this item to the committee.

Steffen questioned how long the study would be valid, and clarification that this study is another opportunity to identify projects that are needed but not in the fiscally constrained planed. Ohrn answered that Environmental Studies sunset, but that this study would not, and that the Managed Lane Vision in the Plan allows for some planning and analysis on future projects.

Arlene McCarthy added that the plan includes a list of projects to study in case new funding becomes available, and that past UPA money for projects may not have been realized if those projects had not been planned and ready.

Steffen reminded the committee that there are MOUs with Mn,DOT, Counties and cities now with studies, and the Metro Council keeps adding more studies. A new administration may direct staff to go in a different direction and build general purpose lanes. She stated that \$15 M has been spend in Anoka County to buy right-of-way for general purpose lanes as instructed in the past.

Motion by Hilker, seconded by Leppik and passed unanimously.

Hearing no objection, Chair McFarlin stated that this item could proceed to the full Council as a Consent Item.

Proposed Action

Background

MnDOT received \$950,000 federal funds to do a congestion mitigation construction project on I-35W. Due to time restriction, the funds will instead be used for a MnPASS feasibility study. On October 20, 2010, the Transportation Advisory Board voted to amend the 2010-2013 TIP to include MN/DOT SP#0280-66: I-35W North Mitigation and Design Feasibility Study from downtown Minneapolis to I-35-E intersection.

BACKGROUND AND PURPOSE OF ACTION: Cong ress appropriated \$950,000 in Interstate Maintenance funds for congestion mitigation on the 35W north corridor. This project is identified in the 2010-2013 TIP as I-35W North Congestion Mitigation and Design north bound Lake Drive to 95th Street in Blaine. The intent was to construct an auxiliary lane at this location. FHWA has recently informed MN/DOT that these funds will expire at the end of September 2010 and will not be extended. Since that does not provide enough time for a construction project, MN/DOT requested a scope change to FHWA to instead do a MnPASS feasibility study between downtown Minneapolis to the I-35W/I-35E intersection. FHWA agreed to allow this amendment so long as it is accepted by the Funding & Programming Committee. Due to the short amount of time before the end of Federal Fiscal Year 2010, some parts of the Metro Council TAB/TAC process will occur after the project has been authorized by the FHWA. TAB was informed of this situation at its September 15 meeting.
