The TAB adopted an amendment to the 2011-2014 TIP to include

MN/DOT SP#2750-73 and SP#1928-59: Cable Median Barrier Installation in New Hope-Brooklyn Park and South Saint Paul-Inver Grove Heights with federal Highway Safety Improvement Program (HSIP) funding.

BACKGROUND AND PURPOSE OF ACTION: These projects are currently identified in the 2011-2014 TIP for 2011 with DPS Section 164 funds, which are state funds. The Office of Traffic, Safety and Technology annually selects projects to utilize federal HSIP funding and these projects were included in the selection for 2011. For this reason, the funding identification must be switched from all state funds to 90% HSIP with a 10% Trunk Highway match. These are in addition to the target amount that metro gets for HSIP. They needed to spend this funding and these two projects were eligible. They have also slightly adjusted the termini from one of the projects. These funds are in addition to our regular target funding so fiscal constraint is maintained.

PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

This amendment is needed to identify the use of federal HSIP funding on each project and to correct an error in the description for project 1928-59.

These projects are currently identified in the 2011-2014 TIP in SFY 2011 as being funded with DPS Sect 164 funds which are state funds. The Office of Traffic, Safety and Technology annually selects projects to utilize federal HSIP funding and these projects were included in the selection for SFY2011. Therefore, the funding identification needs to be switched from all state funds to 90% federal HSIP with a 10% match of TH funds.

Also, at the time of TIP development the description of project 1928-59 was entered incorrectly and should be changed. The original description was "From N. Jet TH 55 in Inver Grove Heights to Wentworth Ave. in S.St. Paul". The total mileage identified has also been changed from 5.3 miles to 5.1 miles.
