Call to Order

Administer Oath of Office - Susan Haigh

A quorum being present, Vice Chair Leppik called the regular meeting of the Metropolitan Council to order at 4:00 p.m. The first order of business was the swearing of Susan Haigh as Chair of the Metropolitan Council. Ms. Haigh is president/CEO of Twin Cities Habitat for Humanity and a former Ramsey County Commissioner. She has a long and diverse history of community and public service in the region. The oath of office was administered by her husband, the Honorable Gregg Johnson, a member of the Ramsey County District Court.

<u>2011-01 SW - 2011 Metropolitan Airports Commission (MAC) Capital Improvement Program (CIP) Review</u>

It was moved by McFarlin and seconded by Peterson

"That the Metropolitan Council finds that:

- 1) The Metropolitan Airports Commission (MAC) has an adequate public participation process for development and review of its 2011 Capital Improvement Program (CIP).
 - 2) An Assessment of Environmental Effects (AOEE) has been prepared and commented on for 2011 projects with potential environmental effects.
 - 3) None of the 2011 projects meet the dollar threshold levels and criteria requiring project approval.
 - 4) Federal, state and local funding for the 2011 CIP, including approximately \$21 million in 2010 bonds, has been identified by the MAC to cover all 2011 projects.
 - 5) All other projects in the 2011 CIP appear consistent with the 2030 Transportation Policy Plan."

Water Supply Report Plan to the Legislature

Keith Buttleman, Assistant GM of Environmental Quality Assurance Department introduced Chris Elvrum, Water Supply Planning Manager, who presented a briefing on the

2011 Legislative Preview Reports

Judd Schetnan, Government Affairs Manager, reported the 2011 Legislative Session began on January 4 and must constitutionally end no later than May 23. The Council's legislative efforts will generally fall into four areas this session:1) state finance process; 2) secure state bond if a bonding bill is developed; 3) passage of Council's legislative policy initiatives; and 4) protecting the Council's areas of responsibilities.

Chair

Chair Haigh reported she is receiving staff briefings on Council business and legislative matters.

Council Members

McFarlin reported the FTA notified CCPO staff that in December they forwarded their recommendation for the CCLRT Full Funding Grant Agreement (FFGA) to the Secretary of Transportation, to stay within the proposed March timeframe; the CCPO received the FTA

Letter of No Prejudice (LONP), allowing project contracts to continue until the FFGA has been received.

Steffen reported the Coon Rapids Regional Dam Commission was advised that a \$16M upgrade would be an effective barrier against Asian carp migrating up the Mississippi River. The Commission is expected to make a recommendation about the future ownership and operation of the dam to the Legislature by March 1.

Regional Administrator

Regional Administrator Weaver reported

- the Office of the Legislative Auditor will release their report on the Governance of Transit in the Twin Cities Region on January 21, 2011;
- Environmental Services wastewater treatment plants have completed 47 consecutive months of perfect compliance.

General Counsel

There was no report.
