Proposed Action

That the Metropolitan Council authorizes the Regional Administrator to extend the current contract with HSQ Technology for support of the Hiawatha Light Rail Transit Control System for up to three additional 1 year terms (an addition of \$500,496). This brings the maximum contract value to \$795,696 over the entire five year period.

Background

When the Hiawatha Light Rail Transit (LRT) was built, HSQ Technology installed the central control system for the line. This system is responsible for providing control and indication of all field equipment in the Rail Control Center (RCC). Without this system, the RCC would not have the ability to monitor or control field equipment, track trains, or gather required statistics on schedule adherence.

In 2009 this contract was negotiated with HSQ Technology to provide support services for the Hiawatha LRT control system. This contract provided for no cost increase in the first year.

The contract was for one year (2009) with the option to extend for up to four (4) additional 1 year terms. The cost was \$144,000 for the first year with a 5% increase for each additional year. To date \$295,200 has been spent (years 1 and 2) under this contract and has an expiration date of May 25, 2011 unless the option to extend for year 3 is utilized.

Rationale

Without vendor support, Metro Transit would be unable to manage or modify the rail control systems due to the proprietary nature of the software. The software and programs in use are customized for our system and would be difficult to support without direct assistance from HSQ Technology.

Funding

Funding for this contract is currently budgeted under rail operating funds.

Known Support / Opposition
