### **Background**

The Council is authorized by legislation to enter into and administer service agreements with transit providers in the metropolitan region. Each of the providers is required to maintain full compliance with all Council policies and with all state and federal laws and regulations that may apply.

Anoka County and Smart Link (Carver/Scott Counties) provide ADA dial-a-ride and Transit Link dial-a-ride service under contract with the Council using small and medium sized buses in their respective counties. Carver/Scott Counties directly operates dial-a-ride service while Anoka County utilizes a turn-key contract with a private provider, MV Transportation, to deliver service in Anoka County and Northwest Ramsey County. Anoka County provides administrative oversight of the service.

A number of significant changes occurred in 2010. Metro Mobility transitioned to paying all contractors on an hourly rate basis. The new Transit Link regional dial-a-ride program was also implemented in 2010 and Scott/Carver Counties also elected to utilize the Smart Link Transit infrastructure to manage all medical assistance transportation needs for county clients.

#### Rationale

Transit Link program funding was distributed among the seven counties in 2010 based on a formula that considered four factors in areas beyond ¾-mile of all-day fixed route service:

- 1. total population
- 2. disability population
- 3. low-income population
- 4. square mileage of service area

Under the advisement of the Coordination Advisory Committee, consisting of transportation and human services staff representatives from each of the seven counties in the metro area, the Council approved the Transit Link funding formula with the understanding that future adjustments might be made to achieve an equitable distribution of funds throughout the metro area.

Given the many complex changes introduced throughout 2010, coupled with the need to analyze trip denials by county to allow adequate evaluation of funding distribution equity, MTS staff recommend extending the service agreements for an additional six months at the current funding levels. This will allow staff to adequately analyze service and performance data and determine if adjustments are warranted for the next two-year contracts effective January 1, 2012.

#### **Funding**

Funding for these service contracts is included in the Metropolitan Council's adopted 2011 Unified Operating Budget.

#### **Known Support/Opposition Issue(s)**

No known opposition. Anoka, Scott and Carver county staff support this action.
