## **Proposed Action**

That the Metropolitan Council:

- 1. Approve the Indian Mounds Regional Park Master Plan Amendment (Referral No. 50010-1).
- Request the City of St. Paul to submit plans for the following park improvements to Scott Denz at MCES for review: 1) the new paved loop trail located just north of Warner Road; and 2) the restroom/shelter facility at Carver's Cave overlook parking lot.

## Background

The City of St. Paul has submitted a master plan amendment for Indian Mounds Regional Park (Referral No. 50010-1) for review by the Metropolitan Council. This is an update to the 1981 master plan.

## Rationale

Minnesota Statute 473.313, Subdivision 1 requires Regional Park Implementing Agencies to, "...prepare, after consultation with all affected municipalities, and submit to the Metropolitan Council, and from time to time revise and resubmit to the council, a master plan and annual budget for the acquisition and development of regional recreation open space located within the district or county, consistent with the council's policy plan." (i.e., the *2030 Regional Parks Policy Plan*)

Minnesota Statute 473.313, Subdivision 2 authorizes the Metropolitan Council to review, with the advice of the Metropolitan Parks and Open Space Commission, master plans for the regional park system. Plans are reviewed for their consistency with the *2030 Regional Parks Policy Plan*.

## Funding

The Indian Mounds Regional Park Master Plan Amendment (Referral No. 50010-1) is consistent with requirements of the *Updated 2030 Regional Parks Policy Plan.* 

A portion of the estimated acquisition cost of \$689,000 and park development and natural resource management costs of \$7,692,000 are eligible for Metropolitan Council Regional Park Capital Improvement Program (CIP) consideration.

Metropolitan Council approval of the master plan amendment does not obligate future funding from the Regional Parks CIP to finance those costs. Plan approval only allows the City of St. Paul to seek funding for projects in the plan through the Regional Parks CIP.

## Known Support / Opposition

The Metropolitan Parks and Open Space Commission considered this matter at its July 19<sup>th</sup> meeting and unanimously approved the recommendation. The Commission discussed the policy rationale for excluding regional park funding eligibility for local recreation amenities in the park (tennis court and potentially a basketball court) based on the premise that local facilities do not attract and serve a regional clientele and therefore should be funded with local financing.

### **INTRODUCTION**

The City of St. Paul has submitted a master plan amendment for Indian Mounds Regional Park (Referral No. 50010-1) for review by the Metropolitan Council. This is an update to the 1981 master plan. This memorandum analyzes the master plan against the criteria for reviewing regional trail master plans. It recommends approving the master plan because it is consistent with applicable portions of the *Updated 2030 Regional Parks Policy Plan*.

## **AUTHORITY TO REVIEW**

Minnesota Statute 473.313, Subdivision 1 requires Regional Park Implementing Agencies to, "prepare, after consultation with all affected municipalities, and submit to the Metropolitan Council, and from time to time revise and resubmit to the council, a master plan and annual budget for the acquisition and development of regional recreation open space located within the district or county, consistent with the council's policy plan." (i.e., the 2030 Regional Parks Policy Plan)

Minnesota Statute 473.313, Subdivision 2 authorizes the Metropolitan Council to review, with the advice of the Metropolitan Parks and Open Space Commission, master plans for the regional park system. Plans are reviewed for their consistency with the 2030 Regional Parks Policy Plan. If a master plan is not consistent with Council policy, the Council should return the plan to the implementing agency with its comments for revision and resubmittal.

### MASTER PLAN ANALYSIS

### 1. Boundaries and Acquisition Costs

Indian Mounds Regional Park is located atop the Mississippi River bluffs on the eastern side of downtown St. Paul. It is 111 acres in size and includes the river bluff, steep slopes, rolling hills, woodlands, grasslands and Indian burial mounds which date to the Hopewell Indian era more than 2,000 years ago. Acquisition of the first 17.5 acres occurred in 1892. Other parcels were acquired over time. Plus additional lands were donated by the State of Minnesota to be used as a municipal forest. These lands were adjacent to the State Willow Brook Fish Hatchery, now known as the DNR Fish Hatchery.

The park is bordered by Mounds Boulevard and Burns Avenue to the north, Highway 61 to the east, Warner Road, Burlington Northern Santa Fe railroad property to the south and the Bruce Vento Nature Sanctuary to the west. A 15.8 acre parcel owned by the MN Dept. of Natural Resources (MN-DNR) as part of the DNR Fish Hatchery is identified as a potential future acquisition if the MN-DNR decides to sell the parcel. It is estimated to cost \$689,000. **Figure 1** illustrates the park's boundary and the MN-DNR parcel as "Acquisition Property".

#### **Stewardship Plan**

Since the park has been acquired and developed, there are no stewardship activities for the City of St. Paul to undertake. This section of the plan notes that the City of St. Paul manages the park and works collaboratively with the MN-DNR on natural resource management of the 15.8 acre Fish Hatchery parcel. Fees are collected from reserving picnic shelters in the park.

#### 2. Needs Analysis

The 2010 estimated visits to the park are 162,000. The 2009 visits were 122,000. The Metropolitan Council's Regional Parks and Trails Survey in 2008 found that walking, hiking, dog walking, and relaxing were the top activities in the park. A majority of the park's visitors learn about the Indian Mounds history and to take in the views of the Mississippi River valley from this vantage point. The master plan's development section proposes interpretive signage, trail and view shed improvements, to maintain existing open space for relaxing non-programmed use, and a potential off-leash dog area.


### 3. Development

The guiding principal for developing the park has been to recognize, celebrate, interpret and seek to preserve the historic, cultural and natural resources in a way that fosters stewardship while providing recreational amenities appropriate for a regional park. The estimated total costs to renovate existing facilities and develop new facilities in the park is \$7,692,000 excluding possible costs for constructing a basketball court which is not eligible for regional park grant funding since it is a local recreation facility.

**Table 1** is a list of projects in priority order for the park's development. The location of these projects are shown in **Figures 2 A and 2B**.

## Figure 4: Focus Area 2 of Indian Mounds Regional Park



## 4. Conflicts

The plan calls for the proposed development projects minimize and avoid disturbance to culturally and historically significant sites in the park with no adverse impacts on the Indian Mounds.

The proposed stairway connection to the Bruce Vento Nature Sanctuary must minimize any adverse affect on the view shed to the bluffs and minimize tree removal and erosion.

The proposed trail connection at the Warner Road Bridge needs to be coordinated with Ramsey County. The connection may be difficult due to the location of the lower bluff line to the north and the feasibility to create an accessible connection to the Sam Morgan Regional Trail on the south side of the bridge.

Future development must also adhere to regulations from the Metropolitan Airports Commission since the park is close to the St. Paul Airport. Any applicable Mississippi River Critical Area regulations must also be adhered to since the park lies within the Mississippi River Critical Area.

#### 5. Public Services

The City of St. Paul provides sewer and water utilities to the park and Excel Energy provides electrical utilities. The sewer and water utilities may need to be expanded to the park's western end for the proposed restroom building. Rehabilitation of some existing utilities may also be required.

#### 6. Operations and Maintenance

The master plan includes the annual estimated costs to operate and maintain the park based on existing and proposed amenities. That estimate includes \$791 for maintaining the existing tennis courts—which are a local recreation amenity. The total costs excluding the tennis court maintenance is \$96,684 per year.

#### 7. Citizen Participation

The master plan was prepared in consultation with a Design Advisory Task Force. The task force included representatives from the Minnesota Indian Affairs Council, National Park Service, Friends of Mounds Park, Friends of the Mississippi River, Lower Phalen Creek Project, Cerenity Care Center, and residents of District 4—the neighborhood where the park is located.

A community open house on the plan was conducted in January 2011. Appendix B of the Executive Summary of the plan includes comments from that meeting.

#### 8. Public Awareness

The plan indicates that the Friends of Mounds Park will work with various government agencies and residents to increase awareness of the park. Plus the City of St. Paul will expand its website to advertise special events in the park and work with the Metropolitan Council on its regional park system awareness program.

### 9. Special Needs

The plan indicates that all park facilities will be developed in accordance with the Americans with Disabilities Act. Other guidelines, such as the Minnesota Department of Natural Resources' Trail Planning, Design and Development Guidelines will be used in constructing bicycle and pedestrian trails.

## **10. Natural Resources**

The master plan includes excerpts from "Natural Resource Inventory and Management Plan for Indian Mounds Park" prepared by Great River Greening in 2007. **Figure 6** on the next page illustrates the native and non-native plant communities in the park. The cost to restore degraded plant communities is \$825,000 as depicted in **Table 5**. These costs were also listed in the Section 3 Development of this memorandum. More details are provided here.



## **REVIEW BY OTHER COUNCIL DIVISIONS:**

Environmental Services (Anna Bessel)

We recently received the Indian Mounds Regional Park Master Plan, which describes a variety of improvements to the existing park, including the construction of additional trails and facilities. After reviewing the Plan, it was determined that two of the outlined park improvements are located in the vicinity of Metropolitan Council Environmental Services (MCES) facilities and therefore may result in an impact to the regional system. The improvements of interest include the proposed loop trail, which is labeled "E" on page 13 of the Plan, and the new restroom/shelter facility, which is labeled "1b" on page 14 of the Plan.

Because the improvements outlined in the Plan are adjacent to or coincide with MCES facilities, plans must be submitted for further review to assess any potential impact to the regional system. Therefore, after preliminary plans for the project are completed, it is requested that one set be forwarded to Scott Dentz of MCES for review and comment. The plans should include the following improvements: 1) the new paved loop trail located just north of Warner Road; and 2) the restroom/shelter facility at Carver's Cave overlook parking lot. Coordination with MCES should occur to ensure that MCES facilities will not be negatively affected by any construction activities. The plans should be mailed to the following address:

- 2. Request the City of St. Paul to submit plans for the following park improvements to Scott Denz at MCES for review: 1) the new paved loop trail located just north of Warner Road; and 2) the restroom/shelter facility at Carver's Cave overlook parking lot.
