Agreement With The Public Facilities Authority (PFA).

Proposed Action

That the Metropolitan Council authorizes the Regional Administrator to execute an amendment to the 2011 loan agreement with the Minnesota Public Facilities Authority (PFA) in substantially the same form as the attached agreement.

Background

Business Item 2010-421 approved on January 12, 2011, authorized the Regional Administrator to execute a \$70.0 million loan agreement with the Public Facilities Authority (PFA) to fund eligible capital projects." The proposed amendment simply adds an additional amount, for which the principal will be forgiven to the loan, specifically for two "green" projects at the Metro plant:

- \$525,000 for the non-condensing steam turbine project
- \$450,420 for aeration tank improvements

Both of these projects were recently qualified by the PCA as eligible for the PFA's *Green Project Reserve* which means they are eligible for 25% principal forgiveness in the amounts listed above. PFA has allowed us to add the amounts to the existing loan agreement, so that the \$70 million loan portion of the agreement (that has very favorable interest) will be unchanged. Thus, the full agreement is being increased to almost \$71 million.

Note that Exhibit A to the Agreement lists all the currently eligible projects (and their phases) and it is being updated also with this amendment. This is routine business and the projects listed in Exhibit A may change over time.

The Attachment is the proposed amendment to the Agreement. This has been approved as to form by our Bond Counsel.

Funding

The amendment is to increase the financing amount and designate the principal forgiveness. Assuming we comply with the standard terms, the \$975,420 amount does not need to be paid back. The interest rate on the

unchanged loan portion is 1.77%; all MCES debt service is paid from revenues from municipal wastewater and SAC charges.

Rationale

For the amendment, the rationale is simply securing the less expense capital for ongoing capital projects.

For the business item, the rational is that since the agreement is backed by the Council's general obligation pledge and the total is increasing, Council approval is necessary.

This amendment dated September 13, 2011 is by and between the Minnesota Public Facilities Authority (the "Authority") and the **Metropolitan Council** (the "Borrower"), 390 North Robert Street, St. Paul, Minnesota, 55101 (the "Council").

Recitals

- 1. The Authority has a Bond Purchase and Project Loan Agreement (the "Agreement") with the Borrower identified as MPFA-10-0024-R-FY11 which provides funds from the Clean Water Revolving Fund to fund wastewater treatment projects described on **Exhibit A** of the Agreement and any other additional wastewater treatment projects selected by the Council, certified by the Minnesota Pollution Control Agency (the "PCA") and approved by the Authority in its sole discretion.
- 2. The Date of the original Agreement with the Borrower was January 13, 2011.
- 3. Exhibit A, which describes the wastewater treatment projects, is updated as a part of this Amendment to reflect current PCA certification status of the wastewater treatment projects.
- 4. On June 30, 2011 the PCA certified the Metro Waste Water Treatment Plant Aeration Tanks 9-12 Improvements Project and the Metro Waste Water Treatment Plant Non-Condensing Steam Turbine Generator Project (the "Green Projects") as meeting criteria for Green Project Reserve.
- 5. The total eligible Green Project Reserve cost of the Metro Waste Water Treatment Plant Aeration Tanks 9-12 Improvements Project is \$1,801,682. The total eligible Green Project Reserve cost of the Metro Waste Water Treatment Plant Non-Condensing Steam Turbine Generator is \$2,100,000.
- 6. The Borrower is eligible to receive supplemental assistance in the form of Green Principal Forgiveness (the "Principal Forgiveness") for 25% of the eligible Green Project costs as determined by PCA for project components directly related to green infrastructure, water or energy efficiency improvements per M.S. 446A.07, subd.8 (a) (8).
- 7. Seventy-five percent of the eligible Green Projects costs are and will be financed with Clean Water Revolving Funds under the Agreement.
- 8. The Authority and the Borrower are willing to amend the Agreement to add \$975,420 in Principal Forgiveness for the Green Projects.

Amendment

In this Amendment, deleted terms from the Agreement will be struck out and added terms will be underlined. Paragraph 1 is amended as follows:

1. Total financial assistance under this Agreement is \$70,975,420 and consists of a \$70,000,000 loan from the Clean Water Revolving Fund and \$975,420 supplemental assistance award in the form of Green Principal Forgiveness (the "Principal Forgiveness"). Subject to the conditions hereinafter set

forth, the Authority hereby commits to loan \$70,000,000 (the "Loan") to the Council for the purpose of funding the wastewater treatment projects described on **Exhibit A** hereto. These projects, or any other additional wastewater treatment projects selected by the Council, certified by the Minnesota Pollution Control Agency (the "PCA") and approved by the Authority in its sole discretion, are, to the extent financed by Loan proceeds, herein collectively called the "Project". The Council hereby agrees to accept this Loan by delivery of its general obligation note to the Authority in the form adopted pursuant to Council Resolution, as set forth in **Exhibit C** hereto.

In addition to the Loan, a supplemental assistance award in the form of Green Principal Forgiveness in the amount of \$975,420 (the "Principal Forgiveness") is granted under the provisions of Minnesota Statute 446A.07, subd 8(a)(8), as amended, which is not required to be repaid as long as the requirements in Paragraphs 24, 25, 28 and 29 of the Agreement are met. If the Borrower fails to comply with the requirements of such paragraphs, and such failure continues for 90 days after written notification thereof from the Authority, then the Borrower must repay the Principal Forgiveness, such repayment to be made in the Borrower's next budget year following the demand.

The Principal Forgiveness is allocated to the Metro Wastewater Treatment Plant Aeration Tanks 9-12 Improvements Project and the Metro Wastewater Treatment Plant Non-Condensing Steam Turbine Generator Project (the "Green Projects"). The total Green Project Reserve eligible costs are as follows:
